Re: Request for Confidential Treatment of Information Submitted in Response to RQ23-005 (Unintended Vehicle Movement While In Park (MY) 2015-2019 Kia Soul EV)

Dear Mr. Donaldson:

On behalf of Kia America, Inc. and Kia Corporation (collectively “Kia”), Kia America, Inc. (“KUS”) hereby requests that certain documents submitted in its response to RQ23-005 dated November 21, 2023 be treated as confidential. Pursuant to NHTSA’s guidelines, Kia is submitting its request and associated documents via electronic submission. In accordance with 49 C.F.R. 512.3(c), confidential business information includes trade secrets or commercial or financial information that is privileged or confidential as described in the Freedom of Information Act. See 5 U.S.C. 522(b)(4). Commercial information is considered confidential if it has not been publicly disclosed and if its release is likely to cause substantial harm to Kia’s competitive position. 49 C.F.R. 512.3.

The documents for which Kia is seeking confidentiality were prepared by Kia or on its behalf and contain design, testing, engineering specification information and evaluations that it claims is confidential business information. These documents include the following:
