Please be advised this firm represents Allstate Insurance as subrogee of [REDACTED] with regard to a fire loss that occurred on the above-referenced date at the above-referenced location. Our initial investigation revealed that this fire originated in [REDACTED] attached garage, at or near a 2018 Hybrid Chrysler Pacifica (VIN [REDACTED])

The purpose of this letter is to provide Chrysler with notice of potential exposure for the damages resulting from this loss. We are placing Chrysler on notice of this loss and informing you that Allstate will subrogate for all damages which it will pay its insured pursuant to its policy in the event that further investigation discloses liability on behalf of Chrysler. Adjustment is currently ongoing; however, damages will likely exceed \$400,000.

In the event that you are insured for this loss, we suggest your general liability insurance carrier be placed on notice immediately. If you are self-insured or uninsured, we intend to provide access to the loss site and relevant artifacts. Please note, failure to provide timely notice to your insurance carrier can result in forfeiture of coverage otherwise afforded.

Please contact the undersigned by **October 8, 2019** to advise if a Chrysler representative would like to participate in an examination of the fire scene. Should this correspondence go ignored, Chrysler will waive any and all claims of spoliation should this matter proceed to litigation.

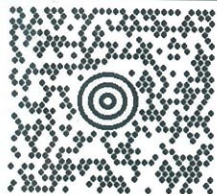

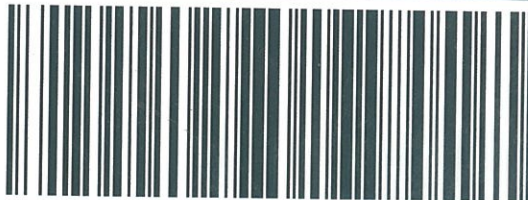
