Dear Michael Wiacek,

This letter is to inform you that the Office of Defects Investigation (ODI) of the National Highway Traffic Safety Administration (NHTSA) has opened a Preliminary Evaluation (PE25009) to assess the scope, frequency, and potential safety consequences related to the Electric Power Steering (EPS) system in model year (MY) 2017–2018 Chrysler Pacifica vehicles manufactured by Chrysler (FCA US, LLC) (FCA), and to request certain information.

This office has received 201 reports of an intermittent sticking sensation during gradual turns, particularly when the steering wheel is positioned near the 11 o'clock or 1 o'clock position in certain Chrysler Pacifica vehicles. Complainants allege increased steering effort is required to return the wheel to center. In many cases, this is followed by a sudden reactivation of EPS assistance, which may result in an oversteer condition. A list of the related reports are included in Enclosure 2 below.

Unless otherwise stated in the text, the following definitions apply to these information requests:

- **Subject Vehicles:** all 2017-2020 Chrysler Pacifica manufactured for sale or lease in the United States, including, but not limited to, the District of Columbia, and current U.S. territories and possessions.
- **Subject Component:** The Electronic Power Steering (EPS) rack and pinion assembly (or Steering Gear) and the Steering Column Control Module (SCCM).
- **Alleged Defect:** Loss, partial loss, or intermittent disruption of Electronic Power Steering (EPS) assist that results in increased steering force at the steering wheel.
- **FCA:** Chrysler (FCA US, LLC), all of their past and present officers and employees, whether assigned to their principal offices or any of their field or other locations, including all of their divisions, subsidiaries (whether or not incorporated) and affiliated enterprises and all of their headquarters, regional, zone and other offices and their employees, and all agents, contractors, consultants, attorneys and law firms and

other persons engaged directly or indirectly (e.g., employee of a consultant) by or under the control of FCA (including all business units and persons previously referred to), who are or were involved in any way as of January 1, 2010, with any of the following related to the Alleged Defect in the Subject Vehicles:

- a. Design, engineering, analysis, modification or production (e.g., quality control);
 - b. Testing, assessment or evaluation;
 - c. Consideration, or recognition of potential or actual defects, reporting, record-keeping and information management, (e.g., complaints, field reports, warranty information, part sales), analysis, claims, lawsuits or arbitrations; or
 - d. Communication to, from or intended for zone representatives, fleets, dealers, or other field locations, including but not limited to people who have the capacity to obtain information from dealers.
- **Document:** "Document(s)" is used in the broadest sense of the word and shall mean all original written, printed, typed, recorded, or graphic matter whatsoever, however produced or reproduced, of every kind, nature, and description, and all non-identical copies of both sides thereof, including, but not limited to, papers, letters, memoranda, correspondence, communications, electronic mail (e-mail) messages (existing in hard copy and/or in electronic storage), faxes, mailgrams, telegrams, cables, telex messages, notes, annotations, working papers, drafts, minutes, records, audio and video recordings, data, databases, other information bases, summaries, charts, tables, graphics, other visual displays, photographs, statements, interviews, opinions, reports, newspaper articles, studies, analyses, evaluations, interpretations, contracts, agreements, jottings, agendas, bulletins, notices, announcements, instructions, blueprints, drawings, as-builts, changes, manuals, publications, work schedules, journals, statistical data, desk, portable and computer calendars, appointment books, diaries, travel reports, lists, tabulations, computer printouts, data processing program libraries, data processing inputs and outputs, microfilms, microfiches, statements for services, resolutions, financial statements, governmental records, business records, personnel records, work orders, pleadings, discovery in any form, affidavits, motions, responses to discovery, all transcripts, administrative filings and all mechanical, magnetic, photographic and electronic records or recordings of any kind, including any storage media associated with computers, including, but not limited to, information on hard drives, floppy disks, backup tapes, and zip drives, electronic communications, including but not limited to, the Internet and shall include any drafts or revisions pertaining to any of the foregoing, all other things similar to any of the foregoing, however denominated by FCA, any other data compilations from which information can be obtained, translated if necessary, into a usable form and any other documents. For purposes of this request, any document which contains any note, comment, addition, deletion, insertion, annotation, or otherwise comprises a non-identical copy of another document shall be treated as a separate document subject to production. In all cases where original and any non-identical copies are not available, "document(s)" also means any identical copies of the original and all non-identical copies thereof. Any document, record, graph, chart, film or photograph originally produced in color must be provided in color. Furnish all documents whether verified by FCA or not. If a document is not in the English language, provide both the original document and an English translation of the document.
 - **Other Terms:** To the extent that they are used in these information requests, the terms "claim," "consumer complaint," "dealer field report," "field report," "fire," "fleet,"

"good will," "make," "model," "model year," "notice," "property damage," "property damage claim," "rollover," "type," "warranty," "warranty adjustment," and "warranty claim," whether used in singular or in plural form, have the same meaning as found in 49 C.F.R. § 579.4.

In order for my staff to evaluate the Alleged Defect, certain information is required. Pursuant to 49 U.S.C. § 30166, please provide numbered responses to the following information requests. Insofar as FCA has previously provided a document to ODI, FCA may produce it again or identify the document, the document submission to ODI in which it was included and the precise location in that submission where the document is located. When documents are produced, the documents shall be produced in an identified, organized manner that corresponds with the organization of this information request letter (including all individual requests and subparts). When documents are produced and the documents would not, standing alone, be self-explanatory, the production of documents shall be supplemented and accompanied by explanation.

Please repeat the applicable request verbatim above each response. After FCA's response to each request, identify the source of the information and indicate the last date the information was gathered. If you do not have the information, please state.

1. State, by model and model year, the number of subject vehicles FCA has manufactured for sale or lease in the United States. Separately, for each subject vehicle manufactured to date by FCA, state the following:
 - a. Vehicle identification number (17-character VIN);
 - b. Make;
 - c. Model;
 - d. Model Year;
 - e. Engine displacement;
 - f. Wheel size;
 - g. Tire size and model installed at factory;
 - h. Trim level;
 - i. Drive train type/configuration;
 - j. Subject component part number and design version installed as original equipment;
 - k. Steering System Software installed on the vehicle at time of manufacture;
 - l. Steering System Software version installed on the vehicle as of date of this request;
 - m. Date of manufacture (MM/DD/YYYY);
 - n. Date of manufacture of the Subject Component (MM/DD/YYYY);
 - o. Alternator rated output (in Amperes)
 - p. Rated capacity of the 12-volt battery (in Ampere-hours and Cold Cranking Amps);
 - q. Date warranty coverage commenced (MM/DD/YYYY); and
 - r. The State in the United States where the vehicle was originally sold or leased, or delivered for sale or lease (postal abbreviation).

If multiple Subject Components exist, provide a separate field for each component. If Subject Components are not associated with a specific VIN, estimate based on the Subject Component usage start date.

Provide the table in Microsoft Access 2010, or a compatible format, entitled "PRODUCTION DATA." A pre-formatted data collection file, which provides further details regarding this submission, will be provided to you.

2. State the number of each of the following, received by FCA, or of which FCA is otherwise aware, which relate to, or may relate to, the Alleged Defect in the Subject Vehicles:

- a. Consumer complaints, including those from fleet operators;
- b. Social media posts;
- c. Field reports, including dealer field reports;
- d. Reports involving a crash, injury or fatality;
- e. Property damage claims (including subrogation claims);
- f. Third-party arbitration proceedings, both pending and closed, where FCA is or was a party to the arbitration; and
- g. Lawsuits, both pending and closed, in which FCA is or was a defendant or codefendant.

For subparts "a" through "g", state the total number of each item (e.g., consumer complaints, field reports, etc.) separately.  - l. Whether FCA or an FCA contractor inspected/investigated the incident;
- m. List of any Diagnostic Trouble Codes (DTCs) recorded;
- n. Whether the Alleged Defect was repaired at a dealership;
- o. Whether the vehicle left the lane of travel;
- p. Weather conditions during incident;
- q. Whether a crash is alleged;
- r. Whether property damage is alleged;
- s. Number of alleged injuries, if any;

- t. Number of alleged fatalities if any; and
- u. Summary of FCA's assessment.

Provide this information in Microsoft Access 2010, or a compatible format, entitled "REQUEST NUMBER TWO DATA." A pre-formatted data collection file, which provides further details regarding this submission, will be provided to you.

4. Produce copies of all documents related to each item within the scope of Request No. 2. Organize the documents separately by category (i.e., consumer complaints, field reports, etc.) and describe the method FCA used for organizing the documents. Describe in detail the search methods and search criteria used by FCA to identify the items in response to Request No. 2. Please discuss with me the search criteria prior to the query.

For each vehicle identified in the responsive data to Request No. 2, provide, in Microsoft Access 2010 or a compatible format, a complete dealer service history within 6 months of (before and after) the alleged incident or report date (whichever is earliest) and report close date.

5. State, by model and model year, a total count for all of the following categories of claims, collectively, that have been paid by FCA to date that relate to, or may relate to, the Alleged Defect in the Subject Vehicles: warranty claims; extended warranty claims; claims for good will services that were provided; field, zone, or similar adjustments and reimbursements; and warranty claims or repairs made in accordance with a procedure specified in a technical service bulletin or customer satisfaction campaign.

Separately, for each such claim, state the following information:

- a. FCA's claim number;
- b. Vehicle owner or fleet name (and fleet contact person), email address and telephone number (please use distinct fields for each data type);
- c. Vehicle owner or fleet street address, city, state (postal abbreviation), and ZIP code (please use distinct fields for each data type);
- d. 17-character VIN;
- e. Vehicle's make, model and model year (please use distinct fields for each data type);
- f. Repair date (MM/DD/YYYY);
- g. Vehicle mileage at time of repair (numeric data type);
- h. Repairing dealer's or facility's name, telephone number, city and state or ZIP code (please use distinct fields for each data type);
- i. Labor operation number(s);
- j. Problem code(s);
- k. Diagnostic trouble code(s);
- l. Replacement part number(s) and description(s);
- m. Customer concern or complaint description;
- n. Technician's cause analysis or comment;
- o. Correction or repair action taken; and
- p. Additional comments, if any, by dealer/technician relating to claim and/or repair.

Provide this information in Microsoft Access 2010, or a compatible format, entitled "WARRANTY DATA." A pre-formatted data collection file, which provides further details regarding this submission, will be provided to you.

6. Describe in detail the search methods and search criteria used by FCA to identify the claims in response to Request No. 5, including the labor operations, problem codes, diagnostic trouble codes, part numbers and any other pertinent parameters used.
7. Provide a list of all labor operations, labor operation descriptions, problem codes, and problem code descriptions, diagnostic trouble codes and diagnostic trouble code descriptions applicable to the Alleged Defect in the Subject Vehicles. State whether the diagnostic trouble codes are automatically reported to the warranty database electronically or manually entered into the warranty database by a claims administrator.
8. State, by make and model year, the terms of the new vehicle warranty coverage offered by FCA on the Subject Vehicles (i.e., the number of months and mileage for which coverage is provided and the vehicle systems that are covered). Describe any extended warranty coverage option(s) that FCA offered for the Subject Vehicles and state by option, model, and model year, the number of vehicles that are covered under each such extended warranty.
9. Produce copies of all service, warranty, and other documents that relate to, or may relate to, the Alleged Defect in the Subject Vehicles, that FCA has issued to any dealers, regional or zone offices, field offices, fleet purchasers, or other entities. This includes, but is not limited to, bulletins, advisories, informational documents, training documents, or other documents or communications, with the exception of standard shop manuals. Also include the latest draft copy of any communication that FCA is planning to issue within the next 120 days.
10. Describe all assessments, analyses, tests, test results, studies, surveys, simulations, investigations, inquiries and/or evaluations (collectively, "actions") that relate to, or may relate to, the Alleged Defect in the Subject Vehicles that have been conducted, are being conducted, are planned, or are being planned by, or for, FCA. For each such action, provide the following information:
 - a. Action title or identifier;
 - b. The actual or planned start date;
 - c. The actual or expected end date;
 - d. Brief summary of the subject and objective of the action;
 - e. Engineering group(s)/supplier(s) responsible for designing and for conducting the action; and
 - f. A brief summary of the findings and/or conclusions resulting from the action.

For each action identified, provide copies of all documents related to the action, regardless of whether the documents are in interim, draft, or final form. Organize the documents chronologically by action.

11. Describe all modifications or changes made by, or on behalf of, FCA in the design, material composition, manufacture, quality control, supply, installation or software of the Subject Component, from the start of production to date, which relate to, or may relate to, the Alleged Defect in the Subject Vehicles. For each such modification or change, provide the following information:
 - a. The date or approximate date on which the modification or change was incorporated into vehicle production;
 - b. A detailed description of the modification or change;

- c. The reason(s) for the modification or change;
- d. The part number(s) (service and engineering) of the original component;
- e. The part number(s) (service and engineering) of the modified component;
- f. Whether the original unmodified component was withdrawn from production and/or sale, and if so, when;
- g. When the modified component was made available as a service component; and
- h. Whether the modified component can be interchanged with earlier production components.

Also, provide the above information for any modification or change that FCA is aware of which may be incorporated into vehicle production within the next 120 days.

12. State the number of each of the following that FCA has sold that may be used in the Subject Vehicles by component name, part number (both service and engineering/production), model and model year of the vehicle in which it is used and month/year of sale (including the cut-off date for sales, if applicable):
 - a. Subject Component; and
 - b. Any kits that have been released, or developed, by FCA for use in service repairs to the Subject Component/assembly or that contain the Subject Component assembly.

For each component part number, provide the supplier's name, address, and appropriate point of contact (name, title, and telephone number). Also identify by make, model and model year, any other vehicles of which FCA is aware that contain the identical component, whether installed in production or in service, and state the applicable dates of production or service usage.

13. Provide the following information related to the theory of operation, design, internal components, and functional characteristics of the Subject Component:
 - a. A plain-language explanation of how the steering rack generates assist and how assist force is translated to the road wheels, and the fail-safe strategy in the event of a sensor or motor fault;
 - b. Internal parts/component breakdown, including major subcomponents, materials, fluids/lubricants, seals, and critical dimensions or tolerances;
 - c. Internal and external parts/component breakdown, including electrical connectors (including pin-out diagrams), sensors (specifically torque and angle sensors), motors, gears, reduction mechanisms, and control modules;
 - d. Functional block diagrams; and
 - e. All schematics, exploded diagrams, engineering drawings, and parts diagrams.
14. Provide the following information related to the Subject Component diagnostics, performance, and specifications:
 - a. A complete list of all Manufacturer Diagnostic Trouble Codes (DTCs) related to the Subject Component, including the code description, the Malfunction Indicator Lamp (MIL)/telltale behavior (e.g., flashing vs. solid), and the operational effect of each code on the vehicle;
 - b. A complete list of Tier 1/Supplier fault codes and associated definitions, triggering criteria, and system-level effects. Identify whether each code is 'history-only' or 'active,' the time required to register the fault, and the specific drive-cycle criteria required to clear the fault from memory;

- c. Operating range specifications (thermal, electrical, mechanical);
 - d. Functional performance data including assist-torque maps; and
 - e. Calibration/pressure curves.
15. Provide the following steering related performance specifications for the Subject Vehicles:
- a. The minimum force a driver must exert to turn the wheel;
 - b. The maximum force a driver must exert to turn the wheel, particularly if the power assist fails; and
 - c. What is the maximum allowable specification for transient steering torque spikes (momentary loss or fluctuation of assist), and what validation criteria exist to ensure these fluctuations do not cause driver over-compensation leading to oversteer.
16. Provide the following information regarding the repair, and teardown processes related to the Subject Component:
- a. The complete repair and replacement procedure for the Subject Component; and
 - b. The detailed failure analysis protocol used by FCA and/or the Supplier to evaluate parts returned from the field, including the step-by-step disassembly process, inspection points, and the specific method used to retrieve fault data from the component's memory.
17. Furnish FCA's assessment of the Alleged Defect in the Subject Vehicles, including:
- a. The causal or contributory factor(s);
 - b. The failure mechanism(s);
 - c. The failure mode(s);
 - d. The risk to motor vehicle safety that it poses; and
 - e. What warnings, if any, the operator and the other persons both inside and outside the vehicle would have that the Alleged Defect was occurring, or Subject Component was malfunctioning; and
 - f. The reports included with this inquiry.

Legal Authority for This Request

This letter is being sent to FCA pursuant to 49 U.S.C. § 30166, which authorizes NHTSA to conduct any investigation that may be necessary to enforce Chapter 301 of Title 49 and to request reports. It constitutes a new request for information.

Civil Penalties

FCA's failure to respond promptly and fully to this letter could subject FCA to Civil Penalties pursuant to 49 U.S.C. § 30165 or lead to an action for injunctive relief pursuant to 49 U.S.C. § 30163. (Other remedies and sanctions are available as well.) The Vehicle Safety Act, 49 U.S.C. § 30165(a)(3), provides for Civil Penalties of up to \$27,874 per violation per day, with a maximum of \$139,356,994 for a related series of daily violations, for failing or refusing to perform an act required under 49 U.S.C. § 30166. See 49 C.F.R. § 578.6(a)(3). This includes failing to respond completely, accurately, or in a timely manner to ODI information requests.

If FCA cannot respond to any specific request or subpart(s) thereof, please state the reason why it is unable to do so. If on the basis of attorney client, attorney work product, or other privilege, FCA does not submit one or more requested documents or items of information in response to this information request, FCA must provide a privilege log identifying each document or item withheld, and stating the date, subject or title, the name and position of the person(s) from, and the person(s) to whom it was sent, and the name and position of any other recipient (to include all carbon copies or blind carbon copies), the nature of that information or material, and the basis for the claim of privilege and why that privilege applies.

Confidential Business Information

If FCA's response contains any information that you claim is confidential business information (CBI), you will need to upload a "confidential version" file and a redacted "public version" file of each file for which FCA is requesting confidential treatment to NHTSA's Safety Defect Investigations (SDI) Portal. For each file submitted through the SDI Portal for which FCA is requesting confidential treatment, FCA must check the "Contains CBI" box. Once all FCA's files have been uploaded in the SDI Portal, FCA will need to click on the "Finalize CBI Submission" button in the SDI Portal and then submit its request letter for confidential treatment and Part 512 certification directly to the Office of the Chief Counsel in NHTSA's Confidential Business Information (CBI) Portal.

After FCA submits its request for confidential treatment and certificate in NHTSA's CBI Portal, the CBI Portal will assign a package identification number for your future reference and all "confidential version" and "public version" files submitted as part of the CBI request will be accessible by both NHTSA's Office of the Chief Counsel and NHTSA's Office of Defects Investigation.

Please refer to PE25009-01 in FCA's response to this letter and in any request for confidential treatment that FCA may submit in response to this letter.

Please see enclosure 1 for additional instructions on submitting a request for confidential treatment that is compliant with 49 CFR Part 512 (specifically, a request for confidential treatment must include the required parts that are discussed in enclosure 1).

Due Date

FCA's response to this letter must be submitted to this office by May 18, 2026. If FCA finds that it is unable to provide all of the information requested within the time allotted, FCA must request an extension from me through the Safety Defects Investigation Portal no later than five business days before the response due date. If FCA is unable to provide all of the information requested by the original deadline, it must submit a partial response by the original deadline with whatever information FCA then has available, even if an extension has been granted.

ENCLOSURE 1 - INFORMATION FOR REQUESTS FOR CONFIDENTIAL TREATMENT

If you believe that your response contains any material that you claim is confidential business information, submit these materials to NHTSA's Office of the Chief Counsel in accordance with 49 C.F.R. Part 512. **All requests for confidential treatment should be submitted directly to the Office of the Chief Counsel via NHTSA's Confidential Business Information (CBI) Portal.** If you do not currently have a user account in the CBI Portal, you may send a registration request to the CBI Portal's Help Desk at cbi-helpdesk@dot.gov.
