ALTERNATIVE DISPUTE RESOLUTION (ARBITRATION) AGREEMENT

As an inducement to Edwards Chevrolet - 280, Inc., Inc. to accept the Customer's vehicle for repair, Customer agrees that any dispute, claim or controversy of any kind arising out of this repair, shall be submitted to final and binding arbitration in the county of the Customer's residence, before a single arbitrator of the American Arbitration Association pursuant to the Consumer Due Process Protocol Statement of Principles of the National Consumer Disputes Advisory Council; provided, however, the parties shall first seek to resolve any dispute through good faith negotiation and/or mediation; and provided, further, the Customer may seek remedies at law for any amount in controversy within the jurisdictional limit of the Small Claims Division of the district courts of Alabama. Edwards Chevrolet - 280, Inc., Inc. shall provide a copy of the Consumer Due Process Protocol to the Customer at the request of the Customer.

I hereby authorize the repair or service work herein set forth to be done by Edwards Chevrolet - 280, Inc., Inc. (Edwards) and I agree to pay for the parts, labor, and other charges. I agree that Edwards is not responsible for any delays caused by the unavailability of parts or delays in the shipment of parts by suppliers or transporters. I hereby grant Edwards' employees permission to operate the vehicle on streets, highways or elsewhere for the purpose of testing and/or inspection. I acknowledge your mechanic's lien in the vehicle to secure the payment for repairs to the vehicle. Edwards makes NO WARRANTIES, either expressed or implied, INCLUDING ANY IMPLIED WARRANTY OF MERCHANTABILITY OR FITNESS FOR A PARTICULAR PURPOSE with respect to parts. Any warranty covering parts shall be that of the manufacturer. For Body Shop repair work, labor is warranted for one year as described in the Edwards Chevrolet - 280, Inc., Inc., Body Shop Limited Warranty. For Service Department mechanical work, labor is warranted for one year or 12,000 miles, whichever occurs first.
