

SETTLEMENT AND RELEASE OF ALL CLAIMS

I, [REDACTED] (the "Releasor"), for myself, my spouse, and my assigns, heirs and executors, in consideration of eleven thousand Dollars (\$11,000.00) to be paid by General Motors LLC ("GM"), hereby forever release and fully discharge GM, its members, its corporate parents, its subsidiaries, its affiliates, its authorized independent dealers, any designers and suppliers of GM vehicles, parts and components, and their respective agents, employees and representatives (collectively, the "Releasees") of and from any and all claims, causes of action, demands, damages, losses, and/or other charges of any kind, including attorney fees and costs, which directly or indirectly arise from, relate to, or are in any way associated with the purchase, use, operation, service, maintenance, repair, or the New Vehicle Limited Warranty (the "Warranty") that GM issued for the 2020 GMC Sierra, VIN [REDACTED] (the "Subject Vehicle"), including without limitation any claims or allegations of purported defects or nonconformities in the Subject Vehicle.

Notwithstanding Releasor's release of all claims concerning the purchase, use, operation, service, maintenance, or repair of the Subject Vehicle and/or the Warranty, GM will honor the remaining coverage periods under the Warranty, if any.

This Settlement and Release of Claim (the "Agreement") shall not be construed to release the Releasees from any claim(s) for personal injury or property damage under a theory of product liability that might accrue, if at all, as a result of the use or operation of the Subject Vehicle after the date below.

Releasor hereby affirms that (s)he has not initiated and will not initiate any court, arbitration, or other legal proceeding against Releasees concerning the Subject Vehicle or the Warranty. If Releasor already initiated such proceedings, (s)he will dismiss them, with prejudice, within one week after they have executed this Agreement.

Releasor hereby affirms that the Subject Vehicle has 56,000 miles/kilometers on the odometer as of the date below.

Releasor acknowledges, agrees, and affirms that (s)he has carefully read and understands this Agreement. Releasor also acknowledges, agrees, and affirms that this Agreement constitutes the entire agreement between Releasor and GM and that Releasor is not relying on any representations, promises, or inducements from any Releasee, other than the terms of this Agreement.
