 FOUND THE ENGINE HAD A NO START. THE STARTER FUSE WAS BLOWN. REPLACED THE BATTERY FUSE BLOCK AND RETRIED. THE STARTED HAD THE CORRECT POWER BUT WOULD NOT OPERATE. CHECKED AND FOUND THE ENGINE ASSEMBLY FAILED AND WAS LOCKED UP THAT CAUSED THE STARTER AND FUSE TO FAIL. HAD TO LOWED THE FRONT DIFF TO GAIN ACCESS AND FREE THE LOCKED ENGINE 2.5 OLH IS NEEDED. 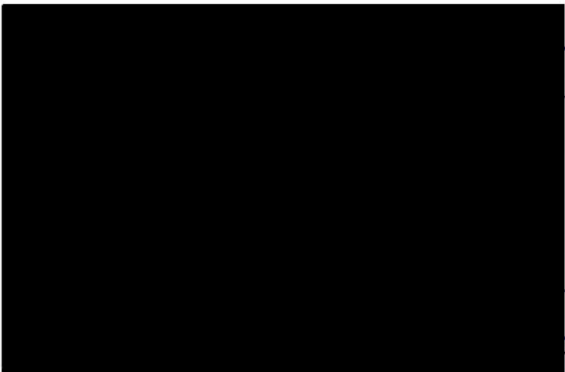
