Obtained oil sample from oil pan and it has excessive metal in it. Removed oil pan and inspected rod and main bearings. Rod bearings are good. Crank shaft around thrust bearing looks over heated. Removed main bearing cap and verified main bearing damage. Thrust bearing spun. Evacuated R1234yf. Removed and replaced engine. Replaced applicable seals, gaskets, pipes, belts and fluids. Replaced radiator and oil cooler lines per bulletin 22NA074. Recharged HVAC system 9A248G4A8000000003w00001. Old N1203521CU8X0037 New 40204230 (4067490 4wd with f47. Need OLH for tear down.)
