FULL RELEASE OF ALL CLAIMS

I, [REDACTED] ("Releasor"), hereby release and discharge General Motors LLC ("GM"), Hilton Head Buick GMC Cadillac, and their officers, directors, shareholders, attorneys, subsidiaries, agents, employees, authorized independent dealers, and any designers and suppliers of vehicles, parts and components that are distributed by GM, from any and all claims, causes of action, demands, damages, and claims for attorney's fees and costs which directly or indirectly arise from, are related to, or are in any way associated with the purchase, lease, repair, maintenance, operation, alteration, or use of the 2024 Cadillac Escalade bearing Vehicle Identification Number [REDACTED] (hereinafter referred to as "subject vehicle"), including but not limited to any claims based on any alleged defects in the subject vehicle and any claims for any alleged failure to timely and/or effectively repair defects in the subject vehicle. This Full Release of All Claims shall not be construed to release any of the above named persons or entities from any liability for bodily injury or property damage arising out of any accident involving the subject vehicle occurring after the date of execution of this release.

In exchange for the above Release and clear title to, and possession of the subject vehicle, GM will issue a single draft for \$109,958.82 made payable to Releasor and Releasor's attorneys which includes \$5,000.00 in fees to Kelaher, Connell & Connor, P.C.

Releasor will relinquish the subject vehicle with its keys to GM, with no damage other than ordinary wear and tear, and sign any additional documents necessary to provide GM with authority to execute any and all duties imposed upon GM as per this Release and to enable GM to acquire clear title to the subject vehicle free and clear of all liens.

Releasor and GM shall submit an Order of Dismissal with Prejudice of the subject lawsuit captioned [REDACTED] v. *General Motors LLC*, pending in the Court of Common Pleas in the

Fifteenth Judicial Circuit for the County of Horry, South Carolina, Case No.: ██████████

It is understood and agreed that this settlement is the compromise of a disputed claim and GM denies liability and intends merely to avoid litigation and buy its peace.

It is further understood that this settlement is a confidential settlement, the terms of which will not be disclosed to any third person except as required by law. Releasor and her attorneys and representatives shall make no written or oral disclosure of any nature relating to this Agreement to any person or entity not a party to this litigation, except for disclosure to accountants and for tax matters, disclosure of safety related information (excluding the terms, and conditions, and amount of this settlement) to government and/or regulatory entities, or as otherwise required by law. Nothing in this Agreement shall be construed as preventing the parties from cooperating with any government investigation.

Releasor specifically understands and agrees that neither GM nor any of its attorneys, consultants, employers, or representatives have made any representations to the Releasor regarding the tax consequences of this Agreement. On the contrary, Releasor and her attorneys have been expressly advised to confer with consultants knowledgeable about the tax consequences of this Agreement and any payments made pursuant to it. Releasor and Releasor's attorneys release GM from any and all liability in connection with any such tax consequences.

This Release is freely and voluntarily executed by Releasor after having been apprised of all relevant information furnished by Releasor's own attorneys. Releasor has carefully read and understands this Release. Releasor, in executing this Release, is not relying on any inducements, promises or representations made by GM or its attorneys that are not contained in this Release.

Furthermore, no promise, inducement or agreement not contained in this Release has been made and this Release contains the entire agreement between the parties hereto, and the terms of this Release are contractual and not merely a recital.

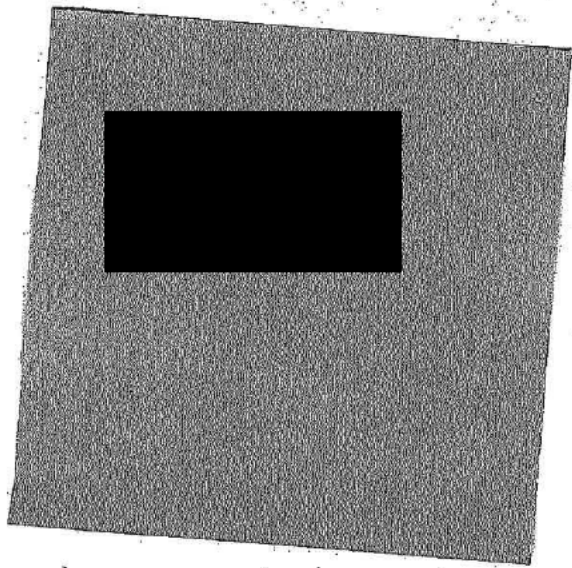
