PAYMENT OPTIONS

- **Payoffs:** For information on your payoff balance, call us at 866-999-0116. Enter your loan and identity information. You may choose to leverage our automated telephone service to receive this information, speak to an agent or have a payoff quote mailed to you.

IMPORTANT INFORMATION

- **Credit Reporting:** We may report information about your account to the credit reporting agencies. Late payments, missed payments, or other defaults on your account may be reflected on your credit report.
- **Special or Disputed Payments:** We may accept late payments or partial payments (to the extent permitted by law) even if marked "payment in full," "without recourse," or similar language without losing any of our rights under your agreement with us.
