- Neither Comprehensive insurance nor Liability insurance for bodily injury and property damage caused to others is included.

- The Maryland Automotive Warranty Enforcement Act gives you certain additional legal rights against the manufacturer in the event your new car does not conform to all applicable manufacturer's warranties during the first 15 months of ownership or 15,000 miles of the vehicle's operation, whichever comes first. To preserve your rights under this law, you must report the non-conformity, defect, or conditions by giving written notice to the manufacturer by certified mail, return receipt requested. If you are buying a new vehicle, the manufacturer's new vehicle warranty delivered to you shall apply between you and the manufacturer. The Dealer is not a party to this warranty. If you are buying a used vehicle, the applicability of an existing manufacturer's warranty thereon, if any, shall be determined by the terms of that warranty.

By signing this Purchase Order Buyer(s) hereby represent, acknowledge, and agree to, the following:

**I. BUYERS OBLIGATIONS.**

- A. When you deliver the Vehicle to me, the sale is final and I understand that you are not obligated to give me a refund or exchange. Upon delivery, the Vehicle becomes a used vehicle.
- B. The credit information I provided is complete and accurate and I have disclosed all instances of non-payment, late payment, or repossession.
- C. I will immediately pay, in cash, any difference between the amount I represent as the payoff and the actual amount that is necessary to remove all existing liens against my trade-in vehicle.
- D. I expressly authorize you to sell my trade-in vehicle at any time after I take delivery of the Vehicle.
- E. I will deliver title to my trade-in vehicle to you within 48 hours after I sign this Purchase Order.
- F. I have legal title to my trade-in vehicle.
- G. I will immediately return the Vehicle to you if this Purchase Order is cancelled for any reason.
- H. I will pay on demand all expenses and costs incurred by you for recovering and repairing the Vehicle if this Purchase Order is cancelled for any reason.
- I. I will deliver my trade-in vehicle to you in the same condition as when you appraised it or pay you cash for the difference between the trade-in allowance and the delivered value.
- J. I grant you a security interest in the Vehicle upon delivery.
- K. I will take delivery of the Vehicle and make settlement hereunder within three days after you notify me of your readiness to make delivery of the Vehicle. Your notice is effective if made in person, by telephone, or by sending written notice to the address on this Purchase Order.
- L. I will promptly pay all sums due under this Purchase Order and any other instrument that I execute in your favor.
- M. When the date of this Purchase Order and the date I take delivery of the vehicle are different you will not have any obligation to update or upgrade the Vehicle if the manufacturer redesigns or improves models similar to the Vehicle.
- N. I will insure that any bank draft given to you is promptly honored in due course by my bank. Dishonor for any reason is a material breach of my obligations under this Purchase Order.

**II. INCREASE OF SALES PRICE/ADJUSTMENT OF TRADE-IN ALLOWANCE.**

- A. If the manufacturer or distributor increases the suggested retail price of the Vehicle or additional equipment prior to delivery, you may increase the price of the Vehicle or additional equipment by the same amount of the price increase. I may cancel this Purchase Order within five (5) days after notice that the price of the Vehicle has been increased.
- B. When actual delivery of the Vehicle is not completed within thirty days from the date I sign this Purchase Order and my trade-in vehicle is not delivered to you at the time I sign this Purchase Order, you may reappraise my trade-in vehicle and reduce the trade-in allowance.

**III. HOLDING AGREEMENT.**

- A. When you deliver the Vehicle to me before I have paid the full purchase price, I authorize you to collect the unpaid purchase price by selling, assigning, or transferring the Finance Documents to the Lender, if I fail, within 5 days of signing this Purchase Order, to pay the full purchase price by certified funds. I understand that interest will begin to accrue from the date I sign the financing documents.

**IV. LEGAL RIGHTS AND REMEDIES OF DEALER ON BUYER'S DEFAULT**

- A. If I default on any of my obligations under this Purchase Order, you as a secured creditor under the Uniform Commercial Code, as enacted in the state of delivery, as amended, shall have the right to:
  - 1. Take immediate possession of the Vehicle without judicial process or court order and;
  - 2. Require me to return the Vehicle to you at a place you designate; and
  - 3. Demand that I pay any and all expenses incurred by you, including attorney fees, resulting from my failure to strictly perform any of my obligations under this Purchase Order.
- B. You may cancel this Purchase Order at any time if:
  - 1. I make any false or misleading representation to you or provide you any false or misleading information with respect to the purchase of the Vehicle or any other matter pertaining to this transaction;
  - 2. I fail to take delivery of the Vehicle and settle under this Purchase Order within three (3) days after you notify me in person, by telephone, or by sending written notice to me of your readiness to make delivery of the Vehicle;
  - 3. I fail to strictly comply with the other terms and conditions of this Purchase Order.
- C. You shall not be liable for failure to tender delivery of the Vehicle due to causes beyond your control; however, I may cancel this Purchase Order if delivery of the Vehicle is not tendered within ninety (90) days from the date of this Purchase Order or from the delivery date (if one is specified) unless manufacturer refuses to cancel my order.
- D. If you cancel this Purchase Order because I have defaulted on any of my obligations under this Purchase Order or you default, I will accept the return of my deposit, the return of my trade-in vehicle, or the "Proceeds" from the sale of my trade-in vehicle, at your option as full satisfaction of all claims hereunder. When you cancel this Purchase Order due to any default or misrepresentation on my part you shall be entitled to commence a lawsuit immediately for breach of contract and retain all or a portion of any down payment or deposit I may have made on the Vehicle. You shall further be entitled to retain or recover from me all charges, expenses, and other costs incurred in removing any special equipment I instructed you to install on the Vehicle. "Proceeds" means the trade-in allowance or the wholesale value received whichever is lower, less total charges for all repairs made to the trade-in vehicle and subsequent trade-in vehicles.

**V. GENERAL TERMS.**

- A. The terms and conditions hereof are governed by the laws of the State of delivery.
- B. This Purchase Order shall be binding upon and shall inure to the benefit of our heirs, personal representatives, successors and assigns.
- C. Time is of the essence as to all terms and conditions of this Purchase Order.
- D. I agree to pay all of your reasonable costs caused by my default under this Purchase Order, including reasonable attorney fees, whether or not suit is filed or a judgment is obtained.
- E. Notice to you is sufficient if mailed to your last known address. If the law does not allow a part of this Purchase Order, that part would be void. The remaining parts will be enforceable. If there is more than one buyer, their obligation shall be joint and several. Any delay or omission in enforcing our rights shall not act as a waiver.
