Before deciding whether to purchase any of these products, you may wish to determine whether your personal insurance or credit card affords you coverage during the rental period. The purchase of any of these products is not required to rent the vehicle.

**NOTICE:** This contract offers, for an additional charge, optional vehicle protection to cover your financial responsibility for damage or loss to the rental vehicle. The purchase of optional vehicle protection is optional and may be declined. You are advised to carefully consider whether to purchase this protection if you have rental vehicle collision coverage provided by your credit card or automobile insurance policy. Before deciding whether to purchase optional vehicle protection, you may wish to determine whether your credit card or your vehicle insurance affords you coverage for damage to the rental vehicle and the amount of deductible under such coverage.



**RIGHT TO INSPECT:** Upon return of the Vehicle or within 72 hours of its return, an Authorized Driver or his or her insurer must notify us that he or she wishes to inspect the damaged Vehicle, or else the right to inspection will be waived. The inspection must be completed within 7 days of the Vehicle's return date. If we determine that the Vehicle is a total loss and subject to salvage, the 72-hour notification period and waiver do not apply, and the Authorized Driver or his or her insurer will have 10 business days from receipt of notification from us to inspect the damaged Vehicle, unless we agree to provide access to the Vehicle beyond the 10 business-day time period.

You agree to purchase and pay for LDW. LDW does not cover all instances of damage to the Vehicle. There are exclusions. Subject to the terms of Paragraph 5 of the Terms and Conditions, we will waive your responsibility for damage to, or loss of, the Vehicle.

You decline to purchase PAC.

You agree to purchase Supplemental Liability Insurance (SLI300). You acknowledge receiving the summary of the terms of the SLI300 policy, SLI300 does not cover all risks. There may be exclusions for unauthorized or intoxicated drivers, no first party uninsured motorist coverage, no coverage for certain passengers in the Vehicle, and other exclusions. Please read the policy summary.

Authorized Drivers are the only persons permitted to drive the Vehicle. If you permit anyone other than the Renter or an Additional Driver listed above to drive the Vehicle, or any other person defined as an Authorized Driver on the rental jacket, we will hold you responsible for damage to the Vehicle and for damage to others and their property caused by the unauthorized driver. Damage caused by unauthorized drivers is not covered by Loss Damage Waiver. There is a small fee to add Additional Drivers to this Agreement.

You decline to purchase any rental liability insurance. You accept primary responsibility for, damage or injury you cause to others or their property, unless another liability insurance product is purchased.

You decline to purchase and pay for a full tank of fuel. If you do not return the Vehicle full, you agree to pay us for the fuel used at 12.99 USD per gallon, plus tax. If you have an electric Vehicle and you return the Vehicle with a charge below 80%, or below the charge level at which your vehicle was provided, you agree to pay a USD 35 charging fee. In addition, if your Vehicle is returned with a charge below 20% you agree to pay an additional USD 20 fee (in addition to the USD 35 charging fee).

You decline to purchase Extended Roadside Protection.

You are responsible for payment of all tolls, violations, and citations assessed during the rental.

We offer two toll service options, General Toll Service and Toll Pass (collectively the 'Toll Products'), that permit you to use automated express/toll lanes.

'General Toll Service' is an additional service that permits you to use automated express/toll lanes for a convenience fee for each day of the rental (regardless of the number of times you use an automated express/toll lane), plus all toll charges you incur ('Incurred Tolls'), which are charged at the highest prevailing undiscounted rate.

Toll Pass' is an additional service that permits you to use automated express/toll lanes at a fixed daily price, regardless of the number of times you use an automated express/toll lane, without being charged for Incurred Tolls.

The Vehicle's toll transponder must be open while driving through automated express/toll lanes in order for the Toll Products to apply. You may purchase either Toll Product at the time of rental or at any time during the rental by calling our reservation department at 1-(888)-749-8227. If you add a Toll Product during your rental, you



must receive confirmation from a Sixt representative that the Toll Product has been added to your Agreement, then ensure the Vehicle's toll transponder is open while driving through automated express/toll lanes. Having the vehicle's toll transponder open without selecting a Toll Product at the counter or through our reservation department will not constitute a purchase of a Toll Product. If you purchase a Toll Product at any time, you will be charged the corresponding per day charge for the specific Toll Product for each day of the rental (regardless of the number of times you use an automated express/toll lane) retroactive to the first day of this Agreement. If you DO NOT wish to use a Toll Product, DO NOT open the Vehicle's transponder box. Certain toll roads do not accept cash. If you do not purchase a Toll Product, to avoid toll violations and associated fines, fees, and taxes (and our administrative fees for processing violations and citations), you must pay all tolls with a personal transponder, use only cash lanes and pay cash, plan a route to avoid tolls, or consult local authorities for other payment methods.

You decline to purchase any of our Toll Products. If you use an automated express/toll lane without purchasing a Toll Product, you will pay us our administrative fee of 15.99 USD per usage day, up to a maximum amount of \$99 per rental agreement plus the applicable toll fee for each time you use an automated express/toll lane during your rental according to the terms of Paragraphs 5 and 5a of the Terms and Conditions. This fee will be charged to your credit card account after the close of this rental transaction.

You decline to purchase Personal Property Coverage (PPC).

**GEOGRAPHICAL RESTRICTIONS:** The Vehicle may only be used in the Contiguous United States and the Canadian provinces of Ontario, Quebec, and New Brunswick (the "Region"). If the vehicle is driven in violation of the territorial restrictions, we will charge you an excess mileage fee of \$0.50 for each mile the vehicle has been driven during the rental. This fee does not limit in any way the total amount or any compensation owed to us under this Agreement. The Vehicle shall not be used in Mexico under any circumstances.

**For One-Way Rentals:** If you have a reservation for a one way rental to return the Vehicle in a state other than the state of pick-up (as shown on the Face Page), the territorial restrictions described above do not apply. However, you may only use the Vehicle in the continental United States, Ontario British Columbia, Canada.

All vehicles are non-smoking. A USD 400 Cleaning Fee will be assessed for violations to this policy.

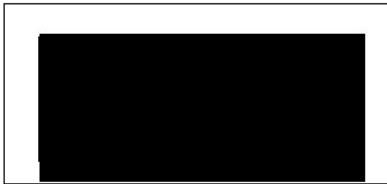
**Vehicle Condition:** It is your responsibility to inspect the Vehicle for damage before leaving our facility. If you discover damage, return to our office and notify us of the damage.



By signing below, you agree to the Terms and Conditions printed on the rental jacket and to the terms found on this Face Page, which together constitute this Agreement. You acknowledge that you have been given an opportunity to read this Agreement before being asked to sign it, and that all information you have provided is true and correct.

Your signature constitutes your agreement to purchase the optional products described above. Your signature allows us to process credit or debit card vouchers in your name for all amounts due us under this Agreement. You permit us to reserve against your card at the beginning of the rental an amount up to three times the estimated total charges as a deposit, in no event less than USD 200, or the amount listed on the Face Page. For Vehicles in the executive or luxury categories, you authorize us to reserve up to USD 5,000 against your card. We may use your deposit to pay any amounts owed to us under this Agreement. You authorize us to charge your credit/debit card after the rental concludes for all tolls and parking violations and fines or penalties assessed against you, us, or the Vehicle during the rental plus our administrative fee of USD 40.00 for each such charge and to release your rental and credit/debit card information to the charging authorities for processing purposes.

I further acknowledge and consent to the dispute resolution provisions contained in the Terms and Conditions.
