



**Memo Granting IR Response Extension Request for PE25018-01**

Dec 17, 2025

This memo documents a Dec 17, 2025, request from Honda (American Honda Motor Co.) for a partial extension of time to respond to the Office of Defects Investigation (ODI) Information Request Letter PE25018-01 for PE25018 dated Nov 18, 2025. The original due date for Honda (American Honda Motor Co.)'s response to Information Request Letter PE25018-01 was Jan 05, 2026.

On Dec 17, 2025, ODI granted Honda (American Honda Motor Co.)'s proposed partial extension for responding to Information Request Letter PE25018-01.
