or any part or accessory and related costs
regardless of fault or negligence.

If your Vehicle was not rented under
the Enterprise Truck Rental brand, the
following will void DW and you will be
responsible for damage to, loss or theft of
the Vehicle:

a. If the Vehicle is damaged when used or driven:

- (1) by any person other than you or an AAD(s);
- (2) by any person under the influence of an intoxicant that impairs driving ability, including alcohol, an illegal drug(s), or a controlled substance;
- (3) when used while engaged in the commission of a crime other than a traffic infraction;
- (4) to carry persons or property for hire;
- (5) to tow or push anything;
- (6) for driver's training;
- (7) to engage in a speed contest;
- (8) outside the continental United States and the use is not specifically authorized by the Contract;
- (9) by you or ADD(s) and you cause damage intentionally or by willful or wanton misconduct; or
- (10) we entered into the Contract based on fraudulent information supplied by you.

The following are added to the Additional Terms and Conditions:

Notice: Your rental agreement offers, for an additional charge, an optional waiver to cover all or a part of your responsibility for damage to or loss of the vehicle. Before deciding whether to purchase the waiver, you may wish to determine whether your own automobile insurance or credit card agreement provides you coverage for rental vehicle damage or loss and determine the amount of the deductible under your own insurance coverage. The purchase of the waiver is not mandatory. The waiver is not insurance.

***If your Vehicle was rented under the Enterprise Truck Rental Brand, the following is also added: Damage Waiver**

does not apply to any loss or damage resulting from theft of vehicle, components or contents, except where required by law; or to overhead damage to the passenger compartment or container; or damage resulting from improper fueling.*

Notice: Your personal automobile insurance may provide coverage for your liability while operating a rental vehicle. The purchase of SLP is not required as a condition of renting an automobile. This insurance does not apply to any bodily injury or property damage arising out of the use of a rental vehicle by any driver while under the influence of drugs or alcohol in violation of the law. The rental car company's employees, agents or endorsees are not qualified to evaluate the adequacy of the renter's existing coverage.

****The Amarillo-Potter events venue district requires that an additional tax of 5% be imposed on each motor vehicle rental for the purpose of financing the civic center expansion and new arena construction projects.**

****McLennan County requires that an additional tax of 5% be imposed on each motor vehicle rental for the purpose of financing a venue project at the heart of Texas Fairgrounds and on surrounding property.**

****LUBBOCK COUNTY REQUIRES THAT AN ADDITIONAL TAX OF 5.00% BE IMPOSED ON EACH MOTOR VEHICLE RENTAL FOR THE PURPOSE OF FINANCING A VENUE PROJECT, CONSISTING OF A NEW MULTI-PURPOSE EXPOSITION CENTER, OTHER ADJACENT SUPPORT FACILITIES AND RELATED INFRASTRUCTURE, APPROVED BY THE VOTERS OF THE COUNTY ON NOVEMBER 6, 2018.**

****The City of El Paso requires that an additional tax of 5% be imposed on each motor vehicle rental for the purpose of financing the Sun Bowl venue project.**
