

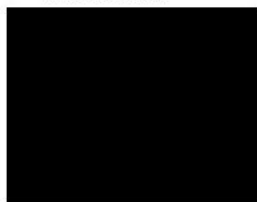

ACCESSED THE DIAGNOSTIC PORT AND PERFORMED A SCAN TO FIND CURRENT CODE(S) P0300 AND P0305. SCAN TESTED VEHICLE AND FOUND CYLINDER 5 WAS A DEAD MISFIRE, REMOVED THE BANK 1 VALVE COVER AND INSPECTED THE VALVETRAIN WHILE THE ENGINE WAS RUNNING AND FOUND THE CYLINDER 5 EXHAUST ROCKER ARM WAS NOT MOVING. 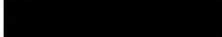
