

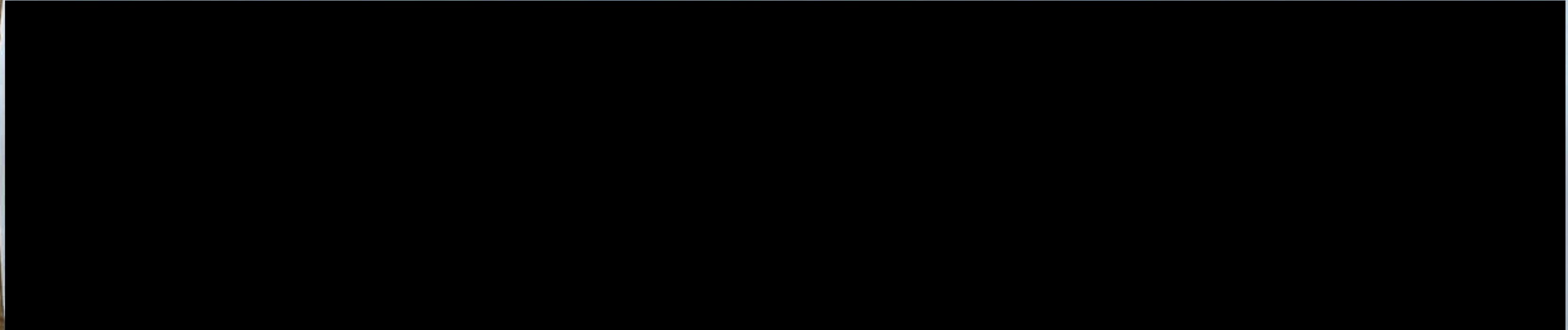

Kendall expressly disclaims liability for special, incidental or consequential damages, or lost profits or wages. If a dispute arises, the parties shall first mediate using the Commercial Mediation Rules of the American Arbitration Association (AAA), and then shall arbitrate using AAA's Commercial Arbitration Rules, with a judgment to be entered upon the arbitration award. Arbitration will be held in Nampa, Idaho. Kendall will pay the fees of Kendall and AAA; Customer will pay Customer's fees.
