Performed visual inspection of engine harness and related power distribution circuits. Found rodent damaged wire at the engine wiring harness near the main power feed, with insulation chewed and conductor partially broken. Condition likely caused intermittent open circuit resulting in loss of power to critical systems and engine shutdown. Repaired chewed wire by soldering and heat shrinking connection, then secured harness and added protective loom to prevent future damage. Cleared DTCs and performed extended road test. Vehicle operated normally with no loss of power or stalling. No codes returned at this time. Vehicle is operating as designed.
