Dear Mr. Person:

I have seen the revised posting on the NHTSA website. With respect to the "means for identifying an involved fuel filter," I believe the following would be helpful.

For 1995-2000 short wheelbase Chrysler Town & Country,  
Plymouth Voyager and Dodge Caravan minivans  
the recalled fuel filters have Part Number 18232 and Date Code 0237, 0249 or  
0252

For 1995-2000 long wheelbase Chrysler Town & Country,  
Plymouth Voyager and Dodge Caravan minivans  
the recalled fuel filters have Part Number 18230 and Date Code 0237, 0249, 0251 or 0304

For 2001-2004 Chrysler Town & Country, Plymouth Voyager  
and Dodge Caravan minivans  
the recalled fuel filters have Part Number 28871 and Date Code 0249  
These part numbers and date codes appear on the gold-tone filter.

While it is possible that some of Intercontinental's customers add identifiers to the filter, we do not believe that anybody removes or obscures the above described numbers.

I also happen to notice a typo: the part number for Queens Plaza Auto Parts should read G7609X, not F7609X. In addition, Pines Auto Product - GAS35 can be removed from the list since none of the GAS35's sold to Pines by Intercontinental were manufactured during the affected period. I have attached a markup to indicate these changes.
