RE: Defect Information Report for Dashboard Airbag Warning Label and Nativa Sun Visor Airbag Alert Label

Dear Ms. DeMeter:

Mitsubishi Motor Sales Caribbean, Inc. (MMSC) submits this letter to provide our recall plan for certain 1998 – 2004 Mitsubishi model vehicles to provide "dashboard airbag warning labels" and for certain 2000 – 2004 Nativa vehicles to provide new sun visor "Airbag Alert Labels." Through NHTSA Docket 2004-19217; Notice 2, MMSC has become aware of the denial of portions of our petition for inconsequentiality for these listed vehicles. Accordingly, the 49 C.F.R. Part 573.5 submitted in August 2004 is updated to reflect the recall plan for the vehicles subject to this denial.

5. Chronological Summary of Events Leading to Determination

In reviewing the drawings and inspecting actual labels for these caution labels, Mitsubishi determined that the Spanish/English caution label for Puerto Rico do not comply with the message area requirement at FMVSS 208 section S4.5.1. Based on this discovery, Mitsubishi issued a Part 573.5 non-compliance report and advised that a petition for inconsequential non-compliance would be filed. On January 26, 2005, NHTSA denied portions of our "petition", specifically that of the Air Bag Dash Warning Labels and the Nativa Air Bag Alert Labels. Based on this denial, MMSC will fulfill its obligation to notify and remedy the labels as required.

7. Proposed Remedy Description

MMSC will mail a customer notification letter containing a written description and a graphic of the bi-lingual dashboard Air Bag Warning Label (pending approval of the design of the letter/label by ODI) that meets the FMVSS No. 208 size requirements (as identified in response to Question 1.). In addition, all current 2000 – 2004 Nativa owners will also receive replacement Air Bag Alert Labels for the sun visors. The sun visor alert label may take additional time pending the ability to obtain self-applying replacement labels that are "permanent" as defined by FMVSS 208. In the event permanent labels are not available, replacement sun visors may be required.

8. Notice(s) and Bulletin(s)

The owner notification and technical bulletin drafts will be provided as soon as possible. Notification to owners for the dashboard Air Bag Warning Labels should begin within 30 to 45 days. The notification to the Nativa owners should begin within 45 - 60 days pending parts availability.
