As a follow-up to the Defect and Non-Compliance Report dated October 25, 2004, ElDorado National (California), Inc. ("ElDorado") hereby submits the following information regarding the recall population for this recall campaign. ElDorado has determined that a total of 766 buses manufactured by ElDorado potentially contain the defective Sure-Lok retractor assemblies. This recall campaign involves 1997 through 2005 model year buses. The buses subject to this recall campaign were shipped by ElDorado during the period from April 1997 through August 2004.
