Re: Toyota Camry/Lexus ES330 Seatbelt Buckle Status Switch Service Campaign

Dear Mr. Weinstein:

As per the discussion at our June 24, 2004, meeting with the agency, this letter is to inform you that Toyota Motor Corporation ["TMC"] has decided to conduct a service campaign to replace the front passenger seatbelt buckle status switch on certain 2004 and 2005 Model Year Toyota Camry and Lexus ES330 vehicles. Those affected, 150,061 vehicles, are only those equipped with a front passenger power seat. A listing of the range of vehicle identification numbers (VIN) for the affected vehicles is attached to this letter.

When installing certain rear-facing infant child seat bases onto the front passenger seat with an excessively high seatbelt tension, it was determined that it may be possible to unseat a component called the buckle status switch ("switch") from the seat belt buckle. While the vehicles comply with all applicable motor vehicle safety standards, if the switch becomes unseated, the front passenger occupant classification system may mistake the rear-facing child restraint for an unbelted adult occupant, and may not suppress the deployment of the front passenger airbag. Toyota has decided to conduct a special service campaign to eliminate the possibility of this occurring in the field.

It is important to note that if this condition were to occur when using a rear-facing child restraint in the front passenger seat, customers would be alerted by both the flashing red seat belt warning lamp, and the yellow passenger "Airbag ON" lamp on the vehicle dashboard. In addition, Toyota recommends that customers never install a rear-facing child restraint in the front passenger seat, even if the passenger "Airbag OFF" lamp is illuminated.
