Please note that P/N 25060-4S425 (Fuel Sending Unit Kit) is used only on vehicles produced prior to 9/1/1999. Approximately 10% of the affected vehicles in the Salt states (see page 2 of TSB04-062 for a list of the Salt states) and less than 1% in the non-Salt states will require this part.

Only the campaign repair in the non-Salt states requires the Protective Coating. P/N KY140-9Z400 can be used for up to 40 vehicles and should be ordered only as needed.
