******* Update to 05/17 Nissan Net Message *******

The purpose of this Nissan Net message is to inform you that the Recall Campaign Bulletin is now available for this campaign and to communicate other important information related to this campaign. See below for additional details.

******* Service Comm *******

It is the dealer's responsibility to check Service Comm for the campaign status on each vehicle falling within the range of this Voluntary Recall Campaign (R0401 for salt states and R0402 for non-salt states) which for any reason enters the service department. This includes vehicles purchased from private parties or presented by transient (tourist) owners and vehicles in a dealer's inventory. Nissan strongly encourages dealers to correct any used vehicles in their inventory before they are retailed.

******* Recall Campaign Bulletin *******

Recall Campaign Bulletin NTB04-062 Frontier/Xterra Fuel Sending Unit Voluntary Safety Recall Campaign is immediately available via ASIST Dial Update and also on NNA.net.com under My Documents in the Service/Campaign and Parts/Campaign folders. The bulletin addresses the specific service procedures and related parts, special tool and claim information.

A visual aid "Pocket Card" which provides a color representation of Page 9 of the Recall Campaign Bulletin is being sent to the attention of the Service Manager at your dealership. If additional cards are needed, they may be ordered from the Resolve Corporation (formerly DDS) at (562)-698-2688. The P/N is "D22/WD22 Insp".

******* Parts Availability *******

An adequate supply of parts is available to support this campaign. Dealers in the salt states (CT, DE, DC, IL, IN, IA, KY, ME, MA, MI, MN, NH, NJ, NY, OH, PA, RI, TN, VT, VA, WV and WI) can expect to receive an initial supply of P/N 25060-4S426 and P/N 25060-4S425 (Fuel Sending Unit Kits) by June 25.

Dealers in the non-salt states (other than those specified above) will also receive an initial supply of P/N B5060-79-900 (Cleaning/Sealing Kit) and P/N KY140-9Z400 (Protective Coating) by June 25.

Please note that P/N 25060-4S425 (Fuel Sending Unit Kit) is used on vehicles produced prior to 9/1/1999 and limited usage of this part is expected. Also, please note that the Protective Coating P/N KY140-9Z400 can be used for up to 40 vehicles. If either of these P/Ns is needed, they must be ordered using the Frontier/Xterra Fuel Sending Unit Campaign Parts Order form. The completed form can be faxed to (310) 771-2626 or e-mailed to campaign.parts@nissan-usa.com. A copy of the form is available on NNA.net.com and is located under My Documents in the Parts/Campaign folder.

If additional parts (other than P/N 25060-4S425 or KY140-9Z400) are required, they can be ordered using the normal parts ordering process.

******* Special Tools *******

A Connector Release Tool (J-47009) is being shipped to the attention of the Service Manager at your dealership.

******* Owner Notification *******

Nissan will begin to send owner notification letters on June 28 informing customers to bring their vehicle to a Nissan dealer. For your reference, a copy of the Owner Notification Letter is provided in the Recall Campaign Bulletin.
