### Unintended Rear Wheel Braking – No Park Brake Warning Lights Displayed – RECALL R166

MODEL 2003 MY  
S-TYPE  
VIN M44998-M72584

Remove and destroy Bulletin 7-26 dated 12/04.  
Replace with this Bulletin.  
Revisions are marked with a bar and in **bold text**.

**Issue:**

A concern has been identified on a number of 2003 MY S-TYPE vehicles within the above VIN range. It is possible that the electronic parking brake can be unintentionally applied resulting in the vehicle decelerating or, in extreme cases, the rear wheels locking up, which may result in a vehicle crash. This condition can occur at any speed without warning lights displayed on the instrument cluster.

Jaguar Cars has made the decision to recall all affected vehicles within the above VIN range for the electronic parking brake module to be renewed.

Recall Action R167 - Unintended rear wheel braking with warning lights, is being released at the same time as Recall Action R166. All of the vehicles in this Recall Action require both R166 and R167. You must ensure that all repairs are completed at one visit. Refer to S206-R167 for repair information.  
A copy of the customer letter is attached.

**Action:**

At the time of confirming a booking for vehicle repair, ensure that all outstanding Field Service Actions are identified to ensure the correct parts are available and adequate workshop time allocated for repairs to be completed at one visit.

To replace the Electronic Parking Brake module, refer to Workshop Manual Section 206-05, SRO 70.35.47.

**Note:** Use WDS to configure the new EPB module after installation.

**Warning:** After replacing the EPB module, destroy the old module by striking it with a hammer to prevent its unintentional reuse.

**Warranty Information:**

Warranty claims should be submitted quoting program code R166 together with option code B as listed in the table below.

No allowance has been made for drive in/drive out, as this repair must be completed at the same time as Recall Action R167.

Jaguar Cars has decided that a defect relating to motor vehicle safety exists on 2003-2004 MY S-TYPE models. If you are a recipient of this notice, and an owner of one of the vehicles within the VIN range listed below, this letter is to inform you that your vehicle is included in this recall.

### **What is the Concern?**

#### **Recall - R167/166**

Investigations have determined that the electronic park brake module, which controls the application of the parking brake, may unintentionally apply the parking brake without any indication or warning to the driver. In some cases warning lights displayed on the instrument cluster may accompany this.

This condition can cause the vehicle to decelerate and, in extreme conditions, may cause rear wheel "lockup" at any road speed, which could result in a vehicle crash without prior warning.

It is important to schedule an appointment with your dealer to have this repair performed.

#### **Recall - R171**

The leaf screen finisher located at the base of the windshield obscures the existing embossed warning on the brake fluid reservoir. Therefore your vehicle is not in compliance with the Federal Motor Vehicle Safety Standard "FMVSS" 135 requirement. Additionally, there is a potential risk of using the incorrect specification brake fluid as a result of the warning statement being obscured. Using the incorrect brake fluid could affect the performance of your vehicles braking system. A listing of all recommended fluids can be found in your owner's handbook.

### **What will Jaguar and your Dealer do?**

#### **R166 or R167**

Jaguar Cars will fit a suppressor module and link lead to the electrical wiring harness to all vehicles included in both recall actions, while only some vehicles will receive a replacement Electronic Park Brake Module.

## R171

Jaguar Cars will also fit a new brake fluid-warning label to your vehicle.

### **What should you do?**

At your earliest convenience you should contact your authorized Jaguar Dealer who will be able to make an appointment to undertake the necessary actions. These recalls will be performed on a **free of charge** basis. To assist your dealer, please ensure that at the time of contact you have at hand your applicable Vehicle Identification Number.

Chapter 301, you may submit a complaint to the Administrator, National Highway Traffic Safety Administration, 400 Seventh Street, S.W., Washington, D.C. 20590 or call the toll-free Auto Safety Hotline at 888-327-4236.

## Unintended Rear Wheel Braking – Park Brake Warning Lights Displayed – RECALL R167

**Issue:**

A concern has been identified on a number of 2003-04 MY S-TYPE vehicles within the above VIN range. It is possible that the electronic parking brake can be unintentionally applied resulting in the vehicle decelerating and in extreme cases, the rear wheels locking up, which may result in a vehicle crash. This condition can occur at any speed and may be accompanied by warning lights or messages being displayed.

Jaguar Cars has made the decision to recall all left-hand drive 2003-04 MY S-TYPE vehicles within the above VIN range to install a windshield wiper motor suppression module and link lead. The workshop procedure is attached.

**Note:** Additional recall actions listed below may need to be performed in conjunction with R167.

Recall Action R166 - Unintended rear wheel braking without warning lights, is being released at the same time as Recall Action R167. For those vehicles that require both R166 and R167, You must ensure that all repairs for both actions are completed at one visit. Refer to S206-R166 for repair information.

Recall Action R171 - Brake fluid warning label - The plenum chamber finisher obscures the existing embossed warning on the brake fluid reservoir. Therefore, Jaguar Cars is not in compliance with the Federal Motor Vehicle Safety Standard (FMVSS) 135 requirement. As a result, a new brake fluid warning label must be applied to the plenum chamber finisher as part of R167. Refer to Warranty section for more information.

### Warranty Information:

Warranty claims should be submitted quoting program code R167 together with the relevant option code from the table below. The options that allow for drive in/drive out can only be claimed when the vehicle has been brought into the workshop for this action alone to be undertaken.

**Note:** There is no dedicated warranty claiming information for the installation of the brake fluid warning label for R171, since this is performed as part of R167.
