# SAFETY PRODUCT RECALL #04083 DATED: JANUARY 10, 2005

## CONDITION

General Motors has decided that a defect, which relates to motor vehicle safety, exists in **certain** 2003 model year Chevrolet Cavalier and Pontiac Sunfire vehicles. Some of these vehicles have a condition where the rear lamps that provide stop and turn signals and tail lamp functions stop working because of inadequate contact between the bulb and socket. If the turn signal is inoperative, the driver should notice a higher rate of turn signal indicator flashes and rapid clicking of the turn signal flasher. In addition, if one bulb were to become inoperative while the vehicle was operating in cruise control, the cruise control would disengage when the remaining bulb was activated. If both lamps were to become inoperative, the cruise control would not engage. If these rear lamps are inoperative, a following

driver may take longer to react to the motion of the vehicle and a crash could occur.

Dealers are to inspect the rear lamp sockets and apply grease or replace them if necessary.
