Dear Mr. Weinstein:

The following information is submitted per your request regarding the list of fleet owners involved in a noncompliance recall (NHTSA 04V-225) on certain 2003 and 2004 model year C/K extended and regular cab pickups and G cargo vans converted to compressed natural gas (CNG) vehicles. Federal, state and local governments purchased 52% of the C/K regular cab pickups, and the other 48% were purchased by businesses. Overall, Federal, state, and local governments purchased 88% of the C/K extended and regular cab pickups and G cargo vans and businesses purchased 31% of the total vehicles involved in this recall. No private owners purchased/leased any of the vehicles involved in the subject recall.
