Dear Mr. Mohr:

Mitsubishi Fuso Truck of America, Inc. (Mitsubishi Fuso) is requested, pursuant to 49 U.S.C. 30165, 30166, and 30119, to renotify owners involved in safety recall 04V-436 who have not had their vehicles corrected or otherwise accounted for. This recall involves 2,609 MY 1996 through 1999 Mitsubishi Fuso trucks manufactured from April 10, 1995, through November 19, 1998. The clearance between the cab main hook and the surrounding components may be insufficient. Repeated normal cab tilting operation could cause the cab tilt system components to become damage in the area of the cab main hook. If damage occurs, the cab main hook could latch improperly, and in the worst case, the cab could tilt forward during normal vehicle operation and a crash could occur without prior warning.

The remedy for this recall is to replace the cab hook, lock lever, and control lever bracket with modified components. Owner notification began on October 28, 2004. Through the third quarter of 2005, Mitsubishi Fuso's fourth reporting quarter, Mitsubishi Fuso reports that of the 2,609 vehicles involved, 684 have been remedied, resulting in a completion rate of 26 percent.

Mitsubishi Fuso should conduct the owner renotification in accordance with the guidelines listed below.


- Before conducting the owner renotification, Mitsubishi Fuso should obtain an updated owner list, for this recall campaign, based on current state motor vehicle registration records.

- Mitsubishi Fuso' proposed owner renotification letter for this recall must meet the requirements of 49 CFR Part 577.10, "Follow-up Notification," and must be submitted to NHTSA for review before owner renotification begins. Part 577.10(e)(1) specifically requires that the renotification letter be identified as a "... follow-up to an earlier communication."
- In addition to the six quarterly status reports required under 49 CFR Part 573.6, "Quarterly Reports," Mitsubishi Fuso is requested to file three additional quarterly status reports.
- Furnish a proposed schedule for conducting the owner renotification that includes the following information:
 - a. the date on which the search of current state motor vehicle registration records will be initiated in order to update the original owner list;
 - b. the approximate date on which the revised owner list will be available to initiate owner renotification;
 - c. the approximate date on which the owner renotification will begin; and
 - d. the approximate date on which the owner renotification will be completed (if the owner renotification is to be staggered, give the beginning and ending owner renotification date for each segment).

Mitsubishi Fuso's renotification schedule and a draft of the proposed owner renotification letter must be submitted to this office by December 7, 2005.
