IMPORTANT MOTORCYCLE SAFETY RECALL

Starter Motor Cable / Oil Cooler Pipe

SPEEDMASTER AND BONNEVILLE AMERICA

Affected VIN range: 139158 – 176552

This notice is sent to you in accordance with the requirements of the National Traffic and Motor Vehicle Safety Act.

Triumph Motorcycles has decided that a defect relating to motor vehicle safety exists in certain 2002-2003 Bonneville America and 2003-2004 Speedmaster motorcycles. There is a possible clearance problem between the oil cooler pipe and starter motor positive cable. If no clearance exists, it is possible for the oil cooler pipe stainless outer cover to abrade the rubber insulator on the positive starter cable creating a spark and a fire.

Our records indicate you are the owner of a Triumph America or Speedmaster – VIN SMT905JNX2J155801

This machine is included within the above Safety Recall and we therefore urge you to contact your local Triumph dealer immediately to arrange for this inspection and/or adjustment to be carried out. This repair will take less than 30 minutes and will be free of charge.

If you had this repair performed before you received this letter, you may be eligible to receive reimbursement for the cost of obtaining a pre-notification remedy of the problem associated with this recall. Please provide the paid invoice to an authorized dealer, or directly to Triumph Customer Service at 385 Walt Sanders Memorial Drive, Suite 100, Newnan, GA 30265

Avoiding this modification may cause an electrical short circuit and possible fire.

Federal regulations requires that any vehicle lessor receiving the Recall Notice must forward a copy of this notice to the lessee within ten days of receipt.
