In regard to your acknowledgement dated July 13, 2004 with respect to the Part 573 report filed on behalf of TRW Vehicle Safety Systems Inc. and certain of its affiliated companies ("TRW") relating to a recall of 1997 Ford Escort front driver side service seatheft assemblies, we submit the following:

- As a result of further investigation, it has been determined that affected vehicles may include 1997

   2003 Model Year Ford Escort and Mercany Tracer 4-door and station wagon platforms rather
  than 1997 Ford Escort 4-door and station wagon platform only as indicated in TRW's Part 573
  report July 02, 2004.
- 2. Concerning your specific comment that "TRW has not yet provided the Agency with a description of the sufsty-related consequence," please refer the following statement included in the proposed owner notification letter referenced in item 3 below: "In the event of a crash, the restraint system may not provide the designed level of restraint, which may increase the risk of personal injury."
- Attached is TRW's druft of the intended owner notification letter and associated mailing envelope for your review and approval prior to distribution to consumers.
- 4. Also attached is a letter that TRW has distributed to Ford / Mercury Dealers requesting a thorough and timely search of their records to identify individual customers to whom they sold the subject service scathelt assemblies. Upon receipt of the requested information from the Ford / Mercury Dealers (due to TRW August 16, 2004) and your approval of the attached owner notification letter, TRW will initiate distribution of the notification to the identified individual consumers.
