Re: Quarterly Reports for Recall 04V-084 and 04V-195

Dear Mr. Pearson:

Please find enclosed the Third Quarter reports for the two recalls referenced above. Workhorse Custom Chassis has had difficulty obtaining information from the State of California on both of these recalls. The State of California requires that a \$50,000 surety bond be posted prior to providing information on names and residential information. I have enclosed with this letter correspondence indicating that the bond has been received and approved, and the residential information will be provided to Workhorse Custom Chassis. We are at the stage where we are waiting for California to provide of the names and residential addresses so that we may complete the recall in the two above-mentioned cases.

The enclosed quarterly report for 04V-084 (Bosch Brake Caliper) is the fifth quarterly report, and it is uncertain as to whether the recall information including the California owners will be completed by the conclusion of the sixth quarterly report. Therefore, we propose providing you with an additional quarterly report (a seventh quarterly report).

In the case of recall 04V-195 (Actia Instrument Cluster), this is only the third quarterly report submitted. Consequently, we will be providing three more quarterly reports, and the California owner information should be provided during that period.

Please advise us on our proposal to add a seventh additional quarterly report for 04V-084. If you have any questions, please contact us.
