Enclosed please find the Vehicle Safety Recall Quarterly Report Information sheet for the second quarter of 2005 for the above-referenced recall campaign involving certain 2004 and 2005 model year Class A Hurricane, Infinity, and Windsport motorhomes equipped with fuel lines on the chassis which could chafe against the steel floor structure, causing the fuel line to rupture.

This quarterly report is being filed in accordance with 49 CFR Part 573.6. Four Winds has previously filed three quarterly reports in connection with this recall campaign. However, in May 2005, Four Winds expanded the recall campaign from 181 vehicles to a total of 402 vehicles. Since an additional 221 vehicles have been added to this recall campaign, Four Winds has agreed to extend the quarterly reporting requirements so that this report constitutes the fourth of nine consecutive quarterly reports to be filed with respect to this recall campaign.


