Dear Mitsubishi Fuso Truck Owner:

This is a follow up to notices you should have received dated October 25, 2004, December 7, 2005 and September 29, 2006 regarding this Safety Recall.

Mitsubishi Fuso Truck of America, Inc. has decided that a defect which relates to motor vehicle safety exists in the cab tilt main hook on certain vehicles. The cab tilt main hook is the latching mechanism that prevents the vehicle's cab from tilting forward during vehicle operation. On affected vehicles, the clearance between the main hook and surrounding components may be insufficient. Repeated normal cab tilting operation could cause the cab tilt system components to become damaged in the area of the cab main hook. If damage occurs, the cab main hook could latch improperly, and in the worst case, the cab could tilt forward during normal vehicle operation, causing a crash without warning.

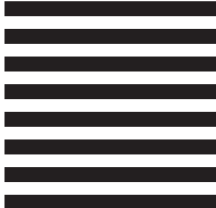
