CERTAIN 2004 CORBEIL SCHOOL BUSES MANUFACTURED BETWEEN MAY 3 AND JUNE 4, 2004. EXPIRED GLUE WAS USED TO ADHERE THE CEILING JOINTS WHICH FAILS TO COMPLY WITH THE REQUIREMENTS OF FEDERAL MOTOR VEHICLE SAFETY STANDARD NO. 221, SCHOOL BUS BODY JOINT STRENGTH.

Consequence:
IN THE EVENT OF A VEHICLE CRASH, THE LONGITUDINAL ROOF JOINT COULD HAVE LESS STRENGTH AS REQUIRED BY FMVSS 221, INCREASING THE RISK OF INJURY.

Remedy:

THE MANUFACTURER HAS NOT YET PROVIDED THE AGENCY WITH A REMEDY OR NOTIFICATION SCHEDULE. OWNERS SHOULD CONTACT CORBEIL AT 450-439-3577.

This recall is the result of an investigation conducted by the Office of Vehicle Safety Compliance, PE-221-050706.

The information in your defect or noncompliance report appears to satisfy the requirements of 49 CFR 573.6 except for the following items:

Effective October 21, 2004, a manufacturer must provide an estimated dealer notification date as well as an owner notification date including the month, day, and year when submitting a defect/noncompliance report (Part 573.6).

You are required to submit a draft owner notification letter to this office no less than five days prior to mailing it to the customers. Also, copies of all notices, bulletins, dealer notifications, and other communications that relate to this recall, including a copy of the final owner notification letter and any subsequent owner follow-up notification letter(s), are to be submitted to this office no later than 5 days after they are originally sent (if they are sent to more than one manufacturer, distributor, dealer, or purchaser/owner).
