This letter is to acknowledge your recent noncompliance information report. Please review the following information to ensure that it conforms to your records as this is the information that will be made available to the public.

**Summary:**

CERTAIN CONVERSION VANS BUILT ON GMC/CHEVROLET CHASSIS FAIL TO COMPLY WITH THE REQUIREMENTS OF FEDERAL MOTOR VEHICLE SAFETY STANDARD NO. 108, "LAMPS, REFLECTIVE DEVICES AND ASSOCIATED EQUIPMENT." THE HOUSING LENS OF THE CENTER HIGH MOUNTED STOP LAMP DOES NOT ALLOW ENOUGH LIGHT TO EMIT FROM THE LAMP.

**Consequence:**

FOLLOWING VEHICLES MAY NOT BE FULLY INFORMED OF VEHICLE BRAKING. REAR-END CRASHES AND INJURY TO OCCUPANTS MAY OCCUR.

**Remedy:**

QUALITY COACHES IS WORKING WITH AUDIOVOX SPECIALIZED APPLICATIONS (ASA) TO REPLACE THE CENTER HIGH-MOUNTED BRAKE LAMP ASSEMBLY. THE MANUFACTURER HAS NOT YET PROVIDED AN OWNER NOTIFICATION SCHEDULE. OWNERS SHOULD CONTACT QUALITY COACHES AT 1-800-373-6357 OR ASA AT 1-800-274-1886.

The information in your noncompliance report appears to satisfy the requirements of 49 CFR 573.6 except for the following items:

Effective October 21, 2004, a manufacturer must provide an estimated dealer notification date as well as an owner notification date (month/day/year) when submitting a defect/noncompliance report (Part 573.6).

We have reviewed your proposed owner letter and it does not meet the requirements of Part 577.

Under "REASON FOR THIS RECALL," please delete the following words from the last sentence: "While injury to vehicle occupants or others is not a direct potential risk." This is considered a disclaimer specifically prohibited by Part 577.8 (b).

The teletypewriter abbreviation in the Hotline paragraph is incorrect. It should read "*TTY: 1-800-424-9153*".


We have reviewed your sample envelope and it meets the requirements of Part 577.

Copies of all notices, bulletins, dealer notifications, and other communications that relate to this recall, including a copy of the final owner notification letter and any subsequent owner follow-up notification letter(s), are to be submitted to this office no later than 5 days after they are originally sent (if they are sent to more than one manufacturer, distributor, dealer, or purchaser/owner).

As stated in your report ASA will be conducting the remedy, and quarterly reporting for this campaign. However, please be advised if ASA's campaign is not satisfactorily handled, the agency will require you to renotify owners.
