(HMC) determined that a defect relating to motor vehicle safety exists in the accessory trailer harness kit sold for the vehicles described below, and is furnishing notification to the National Highway Traffic Safety Administration in accordance with 49 CFR Part 573 Defect and Noncompliance Reports.

The affected kit was designed specifically for the 2005 model year Element. The harness kits manufactured for the 2003 and 2004 model year Element have a different design.

### **Defect description:**

The wire harness of the trailer hitch kit has an incorrectly wired connector. As a result, the trailer brake lamps and turn signal lamps could operate incorrectly, or a fuse could blow causing a sudden loss of brake and turn signal lamp function. Improper signaling or a loss of trailer warning lamp function without warning could cause a crash.

#### **Chronology:**

Mar. 30, 2005 AHM received a report regarding an incorrectly wired trailer wire

harness. HAA initiated an investigation.

Apr. 20, 2005 AHM received the actual failed parts.

May 4, 2005 HAA complete the investigation.

May 6, 2005 HMC determined that a safety-related defect exists.

#### Program for remedying the defect:

The owners of all potentially affected vehicles will be contacted by mail. Owners who have purchased Honda's accessory trailer hitch will be asked to take their vehicle to a Honda dealer. The dealer will correct the connector wiring, free of charge.
