Dear Mr. Medford:

The following information is submitted pursuant to the requirements of 49 CFR 573.6 as it applies to a determination by General Motors of a safety defect involving certain 2005 model year Chevrolet Silverado and GMC Sierra vehicles.

573.6(c)(1): Chevrolet and GMC Divisions of General Motors Corporation.

573.6(c)(2)(3)(4): This information is shown on the attached sheet.

573.6(c)(5): General Motors has decided that a defect, which relates to motor vehicle safety, exists in certain 2005 Chevrolet Silverado and GMC Sierra vehicles. The bolt that attaches the intermediate steering shaft to the steering gear may not meet specification. The bolt may fracture, resulting in the loss of steering. If this happens while the vehicle is moving, a crash could occur without prior warning.

<u>573.6(c)(6)</u>: On January 4, 2005, at the Ft. Wayne Assembly plant, the condition was discovered and on the same day reported to the tier one supplier. Samples of suspect bolts were retrieved from the Ft. Wayne Assembly plant for evaluation and testing.

On January 5, 2005, all assembly plants were instructed to place all the material from lot number 4-34-01 on hold. A similar lot of suspect material was retrieved from Pontiac Assembly plant and delivered to the Textron Fastening Systems metallurgical lab. Based on information received from the GM assembly plants there were 10 instances of bolts breaking during installation. A review of 250 returned parts from the suspect lot concluded that each part was heat treated, but did not achieve the proper level of heat prior to quench. In approximately 10% of the samples tested, parts were below hardness specification. It was concluded from this sample testing that the parts did not reach proper temperature within the furnace. Additionally, a microstructure analysis was performed and it indicated that the parts did pass through the furnace, but did not achieve the correct temperature prior to quench.

The issue was presented to the FPE Director on January 14, 2005. The issue was presented to the GMNA Senior Management Committee (SMC) and on January 19, 2005 the Field Action Decision Committee decided to conduct a safety recall.

573.6(c)(8): Dealers are to replace the bolt that attaches the intermediate steering shaft to the steering gear.

Pursuant to 577.11(e), General Motors does not plan to notify owners about reimbursement because all involved vehicles are within the new vehicle warranty coverage.

# PRODUCT SAFETY RECALL

SUBJECT: INTERMEDIATE STEERING SHAFT TO STEERING GEAR BOLT

MODELS: 2005 CHEVROLET SILVERADO

2005 GMC SIERRA

#### CONDITION

General Motors has decided that a defect, which relates to motor vehicle safety, exists in certain 2005 Chevrolet Silverado and GMC Sierra vehicles. The bolt that attaches the intermediate steering shaft to the steering gear may not meet specification. The bolt may fracture, resulting in the loss of steering. If this happens while the vehicle is moving, a crash could occur without prior warning.

### **CORRECTION**

Dealers are to replace the intermediate steering shaft to steering gear bolt.

The Campaign Initiation Detail Report may contain customer names and addresses obtained from Motor Vehicle Registration Records. The use of such motor vehicle registration data for any purpose other than follow-up necessary to complete this recall is a violation of law in several states/provinces/countries. Accordingly, you are urged to limit the use of this report to the follow-up necessary to complete this recall.

#### PARTS INFORMATION

Parts required to complete this recall are to be obtained from General Motors Service Parts Operations (GMSPO). Please refer to your "involved vehicles listing" before ordering parts. Normal orders should be placed on a DRO = Daily Replenishment Order. In an emergency situation, parts should be ordered on a CSO = Customer Special Order.

#### SERVICE PROCEDURE


#### **Tools Required**

- J 42640 Steering Column Anti-Rotation Pin

#### **Notice**

The wheels of the vehicle must be straight-ahead and the steering column in the LOCK position before disconnecting the steering column or intermediate shaft from the steering gear. Failure to do so will cause the SIR coil assembly to become uncentered, which may cause damage to the coil assembly.

1. Set the front wheels in the straight-ahead position.

- 2. Install J 42640 in the steering column lower access hole.
- 3. For vehicles equipped with a 6.6L diesel engine, remove the left charge air cooler hose.
- 4. Remove the bolt from the lower shaft coupler.
- 5. Install the new bolt to the lower shaft coupler. Tighten

Tighten the coupler pinch bolt to 47 N·m (35 lb ft).

- 6. For vehicles equipped with a 6.6L diesel engine, install the left charge air cooler hose...
- 7. Remove J42640 from the steering column lower access hole.

#### **COURTESY TRANSPORTATION**

The General Motors Courtesy Transportation Program is intended to minimize customer inconvenience when a vehicle requires a repair that is covered by the New Vehicle Limited Warranty. Letters will be sent to known owners of record located within areas covered by the US National Traffic and Motor Vehicle Safety Act. For owners outside these areas, dealers should notify customers using the attached sample letter.

# <u>DEALER RECALL RESPONSIBILITY</u> – For US and Export (US States, Territories, and Possessions)

The US National Traffic and Motor Vehicle Safety Act provides that each vehicle that is subject to a recall of this type must be adequately repaired within a reasonable time after the customer has tendered it for repair. A failure to repair within sixty days after tender of a vehicle is prima facie evidence of failure to repair within a reasonable time. If the condition is not adequately repaired within a reasonable time, the customer may be entitled to an identical or reasonably equivalent vehicle at no charge or to a refund of the purchase price less a reasonable allowance for depreciation. To avoid having to provide these burdensome remedies, every effort must be made to promptly schedule an appointment with each customer and to repair their vehicle as soon as possible. In the recall notification letters, customers are told how to contact the US National Highway Traffic Safety Administration if the recall is not completed within a reasonable time.

### **DEALER RECALL RESPONSIBILITY - ALL**

All unsold new vehicles in dealers' possession and subject to this recall <u>must</u> be held and inspected/repaired per the service procedure of this recall bulletin <u>before</u> customers take possession of these vehicles.

Dealers are to service all vehicles subject to this recall at no charge to customers, regardless of mileage, age of vehicle, or ownership, from this time forward.

Customers who have recently purchased vehicles sold from your vehicle inventory, and for which there is no customer information indicated on the dealer listing, are to be contacted by the dealer. Arrangements are to be made to make the required correction according to the instructions contained in this bulletin. A copy of the customer letter is provided in this bulletin for your use in contacting customers. Recall follow-up cards should not be used for this purpose, since the customer may not as yet have received the notification letter.

In summary, whenever a vehicle subject to this recall enters your vehicle inventory, or is in your dealership for service in the future, you must take the steps necessary to be sure the recall correction has been made before selling or releasing the vehicle.

How Long Will The Repair Take? This service correction will take approximately 15-20 minutes. However, due to service scheduling requirements, your dealer may need your vehicle for a longer period of time.

Contacting Your Dealer: To limit any possible inconvenience, we recommend that you contact your dealer as soon as possible to schedule an appointment for this repair. By scheduling an appointment, your dealer can ensure that the necessary parts will be available on your scheduled appointment date. Should your dealer be unable to schedule a service date within a reasonable time, you should contact the appropriate Customer Assistance Center at the listed number below. The Customer Assistance Center's hours of operation are from 8:00 AM to 11:00 PM, EST, Mondaythrough Friday.
