Dear Mr. Smith:

The purpose of this letter is to correct an error in the original vehicle population submitted to NHTSA pursuant to the requirements of 49 CFR 573.6 on February 4, 2005.

In the February 4, 2005 letter, GM indicated that the total vehicle population was 155,465 vehicles.

As a result of GM's investigation with the supplier, GM determined at that time that this condition can occur on vehicles between 0 and 110 days in service. Additionally, a Weibull analysis predicted there would be no claims after 4 months in service. Therefore, GM decided on January 31, 2005, to conduct a safety recall on dealer stock vehicles and sold vehicles with less than 150 days in service.

However, GM inadvertently reported a total vehicle population of 155,465 vehicles instead of the dealer stock vehicles and vehicles with less than 150 days in service, which total 77,411 vehicles as shown on the attached.
