Vehicle Systems stated that, "Motorhomes that would be affected by this campaign would be manufactured after Dec. 1, 2002 thru April 1, 2005."
Tiffin production schedules were used to see which motorhomes had Hydro-Hots or Aqua-Hots during the specified manufacturing period.

III. Describe the Defect or Noncompliance

According to the notice we received, "The Diesel-Burner is equipped with a Combustion Chamber (burner tube) that may be made out of material that is not within specification & in those cases could fail prematurely."

Describe the cause(s) of the defect or noncompliance condition.

Describe the consequence(s) of the defect or noncompliance condition.

If failure occurs, the surface temperature of the exhaust tube exiting from the heater can increase & could potentially ignite combustible materials in & around the vehicle which could cause personal injury.

Identify any warning which can (a) precede or (b) occur.

Vehicle occupants may notice an increase in noise relating to such an occurrence & may observe heat related discoloration of components of the heater's exhaust system.

Tiffin Motorhomes supplied Vehicle Systems Inc. with a listing of names & addresses of customers who could possibly be affected. Vehicle Systems said they would contact the customers. We also (as of today) supplied our dealers with a letter furnished by Vehicle Systems alerting them to the problem & the repair procedure.
