Blue Bird 2006 model year MicroBird school buses equipped with wheelchair lift manufactured from July 01, 2005 through November 14, 2005.

**5. The noncompliance consists of:**

Omission of shift interlock system when wheelchair lift is installed as required by FMVSS 404 and 403S6.10.10.2.1 and 6.10.2.2.

**6. The following data is the basis for the determination of the noncompliance:**

On November 09, 2005 Blue Bird Engineering was notified of a possible order incompatibility related to wheelchair installations on 2006 model year MicroBird model school buses. Blue Bird Engineering initiated a review of order compatibility data regarding MicroBird school buses equipped with wheelchair lifts.

On November 10, 2005 Blue Bird Engineering reported the option for required shift interlock had not been tied to the option for wheelchair lift installation on 2006 model year MicroBird school buses manufactured after July 01, 2005 thereby resulting in a noncompliance with FMVSS 404 and 403S6.10.10.2.1 and 6.10.2.2..

On November 11, 2005 order compatibility was updated to ensure compliance with FMVSS 404 and 403. An order search found nine MicroBird buses that were built and delivered without the shift interlock feature as required by FMVSS 404 and 403S6.10.10.2.1 and 6.10.2.2.

**7. The noncompliance will be corrected in the following manner:**

The required shift interlock system will be installed on subject buses.

**8. Notification will be as follows:**

Distributor notification is scheduled to be mailed on November 30, 2005.  
Owner notification is scheduled to be mailed on December 07, 2005.  
Parts are anticipated to be available at time of notification.

**9. Blue Bird's identification number assigned to this recall is:**
