Attention – Dealer Principals, Parts and Service Managers

The following are updates/corrections to previously communicated information regarding this campaign.

\*\*\*\*\* Special Tool \*\*\*\*\*

Nissan is shipping a replacement part (L Bracket only) for Special Tool J-47441 (Transmission Jack Adapter) which was shipped to your dealership last week to support this campaign. The replacement bracket provides additional clearance when used to complete the campaign repair on G35 Sedans with full size spare tires. If the replacement bracket is not received by March 10, please contact TECH-MATE at 1-800-662-2001.

Note: There are instructions included in the packaging of the replacement bracket to assist you with the return of the original bracket. Also included is a pre-paid shipping label. Please follow these instructions when returning the original bracket. Brackets not returned within 14 days may be subject to a core charge.

As originally announced, some Infiniti dealers (based on the expected number of vehicles to be repaired) will receive one or more additional adapters within the next 2 weeks.

\*\*\*\*\* Infiniti Net \*\*\*\*\*

The G35/FX Fuel Hose Campaign is temporarily suspended pending shipment of a replacement Special Tool to your dealership. ETA is Friday, March 10.

While only the G35 sedans are affected by this temporary suspension, the campaign is suspended for all affected vehicles (system constraint). However, campaign repairs can continue on G35 Coupes and FX vehicles while this suspension is in effect.

Note: Any Campaign claims submitted prior to Friday will suspend so we suggest you delay any campaign claim submissions until Friday.

\*\*\*\*\* Recall Campaign Bulletin \*\*\*\*\*

Recall Campaign Bulletin ITB06-006 is being revised to include the new part number for the Transmission Jack Adapter. Effective March 10, NTB06-006A is expected to be available on ASIST and on NNA.net under My Documents in the Parts/Campaigns and Service/Campaigns categories.

\*\*\*\*\* Parts Availability \*\*\*\*\*

The parts for this campaign remain on parts sales restriction at this time. You can expect another shipment of parts later this week (same quantities as previous shipment).

The parts sales restriction will remain in effect until next Monday, March 13 at which time additional parts for this campaign can be ordered using the normal parts ordering process.

\*\*\*\*\* Transmission Jacks \*\*\*\*\*

There is a correction to the previously communicated information re: Transmission Jacks.

If you need an additional transmission jack, there are 2 recommended models available for purchase from Nissan TECH-MATE (1-800-662-2001 request Dealer Equipment & Services Option). The dealer prices for these Transmission Jacks range from \$1,379.00 to \$1,548.00 (plus tax and freight) and are subject to change at any time.
