***** Special Tool *****

Special Tool J-47441 (Transmission Jack Adapter) is required to complete this campaign repair. The special tool has been shipped to your dealership. If this tool is not received by March 3, please contact TECH-MATE at 1-800-662-2001.

Some Infiniti dealers (based on number of vehicles to be repaired) will receive one or more additional adapters within the next 2 weeks.

Note: If you need an additional transmission jack, there are 2 models available from TECH-MATE (same phone number as above) and cost is in the \$1,200-\$1,300 range.

***** Parts Availability *****

An adequate supply of parts is available for this campaign repair and you can expect to receive an initial shipment of parts by Friday, March 3. If you do not receive an initial supply of parts by this date, please contact your Dealer Parts and Service Manager (DPSM)

Note: The parts for this campaign will remain on parts sales restriction at this time and you can expect another shipment of parts within the next 2-3 weeks. You will be notified when the normal parts ordering process is reinstated.
