IMPORTANT RECALL INFORMATION (Recall #05V144)

MAY, 2005

Dear Valued Fleetwood Scorpion Owner:

This notice is sent to you in accordance with the requirements of the National Traffic and Motor Vehicle Safety Act.

Fleetwood Folding Trailers, Inc. has decided that certain 2005 model year Scorpion folding trailers fail to conform to Federal Motor Vehicle Safety Standard #108, "Lamps, Reflective Devices, and Associated Equipment".

WHAT IS THE PROBLEM?

The subject folding trailers were not equipped with red reflex reflectors on the rear and red reflex reflectors on the side as far to the rear as practicable. At night, without these reflectors installed, when the folding trailer is approached directly from the rear or the side, the approaching driver will not receive reflected reflex light that indicates a large vehicle is ahead. This can result in a crash without prior warning.

WHAT WILL FLEETWOOD DO?

The recall remedy consists of installing red reflex reflectors to the rear end and rear side of your trailer bumper. This installation will be performed for you at no charge. This should require minimal time and result in little inconvenience to you.

WHAT SHOULD YOU DO?

To have this kit installed on your Scorpion folding trailer, please contact your selling dealer for an appointment. Estimated time of installation is forty-five minutes. The total length of time your folding trailer will be out of service will depend on the service facilities work schedule at the time of installation.

If you have had this concern corrected previously, you may be eligible for reimbursement of your cost for that repair. For more information regarding this recall (#05V144), contact Fleetwood Folding Trailers, Inc. at 800/841-3605.

When you deliver your Scorpion for repairs, your Fleetwood Folding Trailer Dealer will complete a repair order. Upon completion of the installation, please sign the Repair Order.

Please fill out the enclosed *Vehicle Information Update Card* and return it to Fleetwood Folding Trailers, Inc. If you no longer own this vehicle, please take a moment to provide the name and address of the person you sold it to. This will enable us to send this important information to the new owner.

For leased vehicles: Federal regulation requires that any vehicle lessor receiving this recall notice must forward a copy of this notice to the lessee within ten days.

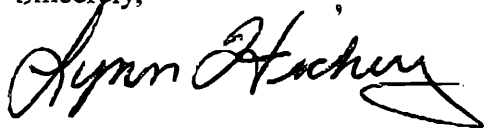
