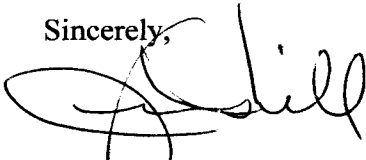
Dear Mrs. Wallace:
