

# Attention: All Kia Service Managers

Kia Motors America, Inc., in cooperation with the National Highway Traffic and Motor Vehicle Safety Act, is conducting a Voluntary Safety Recall Campaign on 2003 and 2004 model year Rio models, as well as certain 2005 Rio models, except Rio Cinco (5-door hatchback). Certain child restraint anchors will not fully latch onto the child lower anchors located between the rear seatback and rear seat cushion because of interference between the child seat lower anchors and a metal wire located in the frame of the rear seatback. You have been sent the following Material:

Technical Service Bulletin that provides the following information:

- Vehicle Repair Procedures
- Affected VIN Production Range
- Warranty Claim Information
- Parts Supply Information

Also enclosed is a copy of the owner notification letter, a Q&A guide for recall questions, both of which describe the noncompliance and the resulting risk to motor vehicle safety, and a list of retail Kia Rio owners affected by the recall. The owner letter will begin being mailed on Monday, January 30, 2006, and will be completed in three waves (1/30/06, 2/6/06 and 2/13/06). Please start performing the repairs on any affected 2003, 2004 and 2005 Rio models produced through June 11, 2005 immediately upon receipt of your initial parts supply shipment

#### What Should You Do

Please make certain the appropriate personnel in your dealership are familiar with the details of this recall to ensure proper responses to customer inquiries and requests to have the recall performed on their 2003, 2004 and 2005 Rio vehicles.

Each dealer will be systematically provided with an initial supply of the parts required to launch this recall. Kia recommends that any additional orders for these parts be placed after the initial shipment has arrived at the dealership.

NHTSA ADVISORY: It is a violation of Federal law for a dealer to deliver a new motor vehicle covered by this notification under a sale or lease until the defect is remedied.

### QUESTIONS AND ANSWERS FOR SAFETY CAMPAIGN (SC057)

#### 2003 - 2005 Rio Child Seat Anchorage System

#### **December 23, 2005**

# Q1. What sort of campaign is Kia conducting?

A1. Kia is conducting a Safety Campaign to replace the child seat lower anchors in all 2003 and 2004 model year Rio models, as well as some 2005 model year Rio models, excluding Rio Cinco models.

### Q2. Why is Kia conducting this campaign?

- A2. Some lower child seat restraint anchors will not fully latch onto the child seat lower anchors of affected vehicles. These child seat lower anchors are located between the rear seatback and the rear seat cushion on certain 2003MY-2005MY Rio Models, excluding Rio Cinco. This occurs because of interference with the lower child seat restraint anchors and a metal wire located in the frame of the rear seatback. Diagrams illustrating the child seat lower anchors can be found on pages 3-52 and 3-53 of the Rio Owner's Manual.
- Q3. Can a child seat be used in affected vehicles until the safety campaign repair is completed?
- A3. Every child safety seat which complies with Federal Motor Vehicle Safety Standards is designed to be properly restrained by the vehicle's rear safety belts, even when the child seat lower anchors are not used. The child lower bar latch system is a supplementary mechanism to enhance the protection of any properly restrained child traveling in the vehicle and some car seats may not be equipped with lower anchors.

Therefore, until the safety campaign repair is completed, instructions provided by the child seat manufacturer on how to properly install the child seat with the vehicle's rear safety belts should be carefully followed.

#### Q4. What vehicles are affected by this safety campaign?

A4. All 2003 and 2004 model year Rio models, as well as those 2005 Kia Rio models manufactured through June 11, 2005.

The affected vehicles were produced at Kia's Kwangju plant in South Korea.

## SAFETY RECALL NOTICE

This notice is sent to you in accordance with the requirements of the National Traffic and Motor Vehicle Safety Act and in the interest of the safety of child occupants of your vehicle. Kia Motors America, Inc. has determined that certain 2003-2005 Rio models are not in compliance with Federal Motor Vehicle Safety Standard 225 (Child Restraint Anchorage Systems). Kia is therefore conducting a recall to correct that noncompliance.

### What is the problem?

• Certain child restraint anchors will not fully latch onto the child lower anchors located between the rear seatback and rear seat cushion because of interference between the child seat anchors and a metal wire located in the frame of the rear seatback. The use of such lower seat anchors combined with the upper tether is considered by NHTSA to provide enhanced protection for occupants of child safety seats used in the rear seats, compared to the use of the existing vehicle safety belts to restrain the child safety seat.

### What can you do to operate your vehicle more safely before the recall is completed?

• Every child safety seat which complies with Federal Motor Vehicle Safety Standards is designed to be properly restrained by your vehicle's rear safety belts even when the child seat anchors are not used. If your current child seat does not have lower anchors, continue to secure the seat with your vehicle's safety belts pursuant to the child seat manufacturer's instructions.

If your current child seat does have anchors, it is highly likely that the anchors will not latch. In that case, secure your child seat with the rear seat safety belts until you have this recall competed. The child lower bar latch system is a supplementary mechanism to enhance the protection of any properly restrained child traveling in your vehicle, and you should therefore have this recall repair conducted promptly. Until the recall repair is completed, follow the instructions provided by your child seats manufacturer on how to properly install the child seat with your vehicle's rear safety belts.

#### What will Kia do?

• Kia will replace the child lower anchors at no cost to you, when you take your vehicle to your Kia dealership.

#### What if you have already paid to have this situation corrected?

If you have incurred expense to remedy this problem prior to the date of this notice, you may have the opportunity to obtain reimbursement for that expense. Since your vehicle is covered by a 5-year/60,000 mile limited warranty, any such repair should have been made under that warranty at no expense to you. However, if you incurred an emergency

repair where you did not have access to a Kia dealer, please contact the Kia Consumer Assistance number listed below for assistance in submitting your claim or mail your receipts with a cover letter directly to Kia for review and consideration:

#### What should you do?

• Please call your Kia dealer to schedule a service appointment. The time required to repair your vehicle should be less than one hour. However, depending on the dealer's work schedule, it may be necessary to make your vehicle available for a longer period of time. Please present this notice when you arrive at the dealer.

### Have you changed your address or sold your Kia?

• If you have changed your home address, sold your Kia vehicle, or no longer own your vehicle, please complete the attached prepaid "Change of Address/Ownership" card and mail it to us.

# What if you are a vehicle lessor?

Federal regulation requires that any vehicle lessor receiving this recall notice must forward a copy of this notice to the lessee within ten days.

#### What if you have other questions?

• If your dealer does not respond to your service request in a timely manner, we suggest that you call Kia's Consumer Assistance Center at 1-800-333-4542. This number has TTY capability. SAFETY RECALL CAMPAIGN: 2003-2005 RIO 4-DR CHILD SEAT ANCHORS SYSTEM

This bulletin provides information relating to a Safety Campaign to replace the rear seat child restraint lower anchors on all 2003, 2004 and 2005MY Rio 4-door (NOT Rio Cinco 5-door) vehicles produced through June 11, 2005.

Certain child seat anchors will not fully latch onto the vehicle child lower anchors located between the rear seatback and rear seat cushion because of interference between the child lower anchors and a metal wire located in the frame of the rear seatback.

Follow the procedure in this Campaign to replace the four existing vehicle lower child seat anchors with new improved anchors.

# ECALL CAMPAIGN: 2003-2005 RIO 4-DR CHILD SEAT ANCHO

### INSPECTION PROCEDURE:

- 1. Open hood and check for SC057 Campaign Completion Label on the bulkhead above the brake booster.
  - If label exists, NO FURTHER ACTION IS REQUIRED.
  - If label DOES NOT EXIST, continue to Child Seat Anchor Removal.

Note: Campaign completion must be verified on the Warranty Coverage Validation screen, prior to performing repairs (KSS Main Menu - Option 3).



- Remove the two (2) rear seat bottom cushion bolts below the front edge of the cushion and remove rear seat bottom cushion from vehicle.
- 2. Remove the three (3) rear seat back retaining bolts located along the bottom of the rear seat back. Lift the seat back up to release the three (3) upper retainers and remove the seat back from the vehicle.
- 3. Remove the four (4) vehicle child seat lower anchors from the vehicle, keep the retaining bolts and discard all four (4) anchors.


#### CHILD SEAT ANCHOR INSTALLATION:


 Install the two (2) new left lower anchors supplied in the Kit — Child Anchor, P/N-Q8999 9FD000Q.

**Note:** There are two (2) left and two (2) right anchors. The left anchors are stamped "FL" and the right anchors are stamped "FR". Install the new larger inboard left anchor stamped "FL" using the three(3) bolts from the original anchor and torque to 16-22 lb-ft.

2. Install the new outboard left anchor stamped "FL" using the two (2) bolts from the original anchor and torque to 16-22 lb-ft.





- 3. Install the new larger inboard right anchor stamped "FR" using the three (3) bolts from the original anchor and torque to 16-22 lb-ft.
- 4. Install the new outboard right anchor stamped "FR" using the two (2) bolts from the original anchor and torque to 16-22 lb-ft.




- 5. Install the rear seat back in the reverse order of removal and torque boits to 16-22 lb-ft.
- 6. Install the rear seat bottom cushion in the reverse order of removal and torque bolts to 16-22 lb-ft.

# \* NOTICE

Make sure all three (3) safety belt buckles and the center lap belt are exposed and in the correct location after installing the rear seat bottom.

7. Install SC057 Campaign Completion Label in the engine compartment on the bulkhead above the brake booster.
