Dear Mr. Smith:

We have been advised by our supplier, KW automotive GmbH, that certain front struts, Part Numbers KW # 61230037, included in Eibach Kits (see below chart) supplied to Eibach by KW contain a potential safety-related defect. According to KW, the front anti-roll bar attachment bracket on the front strut can separate from the strut housing due to inconsistent welding. This could result in a clunking noise and/or poor handling in extreme or emergency maneuvers. Possible tire side wall damage may occur if the broken bracket contacts the tire. This affects the following Eibach Part numbers:

Approximately 400 of the 35101.8001's were sold by Eibach in the aftermarket under the Eibach brand name in the various Kits above. Eibach will recall all of the subject parts. We have enclosed a draft owner letter pursuant to 49 CFR Part 577 for the agency's review. Eibach will replace the subject parts at no charge. Eibach is prepared to begin notification by December 1, 2006.

SAFETY RECALL NOTICE

This notice is being sent to you in accordance with the requirements of the National Traffic and Motor Vehicle Safety Act.

Eibach Springs, Inc. (“Eibach”) has decided that a potential defect which relates to motor vehicle safety exists in certain Eibach front suspension struts. Eibach is recalling the affected product.

This recall involves the front suspension strut for the '05 through '07 Ford Mustang.

WHAT IS THE PROBLEM?

Due to inconsistent welding, the front anti-roll bar attachment bracket on this strut can separate from the strut housing. This could result in a clunking noise and/or poor handling in extreme or emergency maneuvers. Tire side wall damage may also occur if the broken bracket contacts the tire. These conditions could possibly lead to a vehicle crash.
