Pursuant to Part 573 of Title 49 of the Code of Federal Regulations, Volvo Cars of North America, LLC (Volvo) submits the following information concerning a safety recall program that it is voluntarily initiating.

Identification of Vehicles involved
 The vehicles involved in this recall are certain MY2003, MY2004, MY2005, MY2006 XC90 Volvo vehicles.

The assembly plants, chassis numbers and inclusive dates of manufacture for US built vehicles are as follows:

The recalled model population represents 100% of the total population of vehicles assembled between dates provided above for the US market.

A wiper arm with increased arm head strength was introduced in production from October 19, 2005 forward. Vehicles from October 19, 2005 forward are not included in this action.

- Number of Vehicles Potentially Affected.
 The number of vehicles potentially affected by this recall in the U.S. is approximately 122,431.
- 4. Estimated percentage of Vehicles with the Defect.

 The actual number of recalled vehicles with the defect is unknown. This recall remedy will be implemented on 100% of the recalled vehicles.
- 5. Description of the Defect.

In a certain few vehicles, if the wiper arm is activated in extreme winter weather conditions and without lifting the wiper arms and cleaning the windshield prior to takeoff, the wiper arm might slip on its driveshaft, resulting in an inability to move the wipers from parking position.

This may occur when the joint between the wiper spindle and wiper arm head can not transfer the torque from the wiper linkage out to the wiper arm. The result of this is may be a freely rotating spindle within the arm head that penetrates the arm head material splines, which may result in reduced clamping force in the joint.

If this occurs, the customer may notice an inability to move the effected Wiper arm (s) from parking position.

The remedy is replacement to reinforced wiper arms and retaining nuts and the introduction of torque angle assembly.

All vehicles specified in #2 above will be recalled and remedied.

7. Program for Remedy of Defect.

All involved vehicles will be subject to the recall. Vehicle owners will receive a letter via first class mail. The letter will request that the owner of the vehicle take their vehicle to a Volvo retailer for remedy.

The remedy is replacement to reinforced wiper arms and retaining nuts and the introduction of torque angle assembly.

A schedule for notification to the dealers/retailers and customers will be provided to NHTSA at a future date. We are striving to implement this action as soon as possible.

8. Copies of Notices, Bulletins, etc.

Formal retailer notices, bulletins and other communications have not been completed. Copies of all such information will be forwarded to NHTSA as soon as they are available.

Owners that have had an affected vehicle remedied prior to the recall will be reimbursed.
