### **NONCOMPLIANCE INFORMATION REPORT**

#### 1. Manufacturer:

Nissan Motor Company, Ltd.

## 2. Vehicles Potentially Involved:

2005 through 2006 model year Nissan Murano vehicles manufactured from August 23, 2004 to July 24, 2006. Another model has a similar steering lock assembly but the steering assembly housing is different, and the noncompliance is being reported separately. No other vehicles have a steering lock that exhibits this noncompliance.

## 3. Total Number of Vehicles Potentially Involved:

Approximately 67,014.

## 4. Percentage of Vehicles Estimated to Actually Contain the Noncompliance:

Unknown

#### 5. Description of the Noncompliance:

The vehicles fail to comply with S4.3 of Federal Motor Vehicle Safety Standard 114.

#### 6. Basis for Determination of the Existence of a Noncompliance

During an inspection of some vehicles at the assembly plant, it was found that the steering wheel was locked with the ignition knob in the "OFF" position but the vehicle transmission not being in the "PARK" position . Nissan initiated an investigation and inspected the potentially affected steering locks. Based on the inspections, Nissan determined that the steering locks do not meet S4.3 of FMVSS 114.

## 7. <u>Description of Corrective Action:</u>

All potentially affected vehicles will be inspected to see if the steering wheel locks when turned with the transmission not in the "PARK" position and with the ignition knob in the "OFF" position. The steering wheel lock assembly will be replaced in any vehicles that exhibit this condition.
