(VIN last eight characters) -7 = 2007 model year; D = Belvidere Assembly Plant, Belvidere, Illinois; and last six digits = sequential number.

DCC cautions that the above range represents only the lowest and highest VIN sequential numbers included in the recall. This range cannot be used to determine conclusively that a vehicle is involved in the recall because most vehicles with a VIN within the range are not affected by the recall.

Description of defect:

The Owner's Manual does not contain the higher rollover risk warning information required for certain multipurpose passenger vehicles.

The following chronology of principal events occurred in October of 2006 and led to the determination of a defect:

- The 2007 MY Jeep Compass is certified as a multipurpose passenger vehicle (MPV).
- Federal Regulation 575.105 requires that MPVs which have a wheelbase of 110 inches or less and special features for occasional off-road operation contain a Rollover Warning Label on the driver's visor.
- This label refers the customer to the Owner's Manual for further information that is also specified in Federal Regulation 575.105.
- In early October of 2006 it was discovered that although the visor label is present, the required information was inadvertently omitted from the Owner's Manual.

- Addendum cards were produced and updated Owner's Manual kits were delivered to the Belvidere, Illinois Assembly Plant on October 16, 2006 and a clean point established.
- DCC is unaware of any accidents or injuries attributable to this condition.
- This data was presented to the Vehicle Regulations Committee on October 31, 2006 who decided to conduct a safety recall to provide updated Owner's Manual information.

Statement of measures to be taken to correct defect:

DCC will provide the required information for insertion into the Owner's Manuals for all affected vehicles. DCC plans to implement national notification to dealers on November 10, 2006 and expects to begin notification to owners during the week of November 13, 2006.

Involved vehicles can be determined by using the VIP inquiry process.

Subject

The Owner's Manual on about 18,200 of the above vehicles does not contain the higher rollover risk warning information for utility vehicles.

Repair

Dealers are required to copy the rollover addendum (printed on the back of the attached owner notification letter) and place it in the Owner's Manual of all involved vehicles in new vehicle inventory.

Owner's Manual rollover warning addendum letters will be mailed directly to the owners known to DaimlerChrysler. The owners are requested to place the letter in their vehicle's Owner's Manual for future reference.

Parts Information

No parts are required to perform this service procedure.

Service Procedure

- 1. Locate the Owner's Manual in the vehicle's glove box.
- 2. Place a copy of the rollover addendum (printed on the back of the attached owner notification letter) into the Owner's Manual.
- 3. Return the Owner's Manual back into the glove box.

Completion Reporting and Reimbursement

Claims for vehicles that have been serviced must be submitted on the DealerCONNECT Claim Entry Screen located on the Service tab. Claims submitted will be used by DaimlerChrysler to record recall service completions and provide dealer payments.

Vehicle Lists, Global Recall System, VIP and Dealer Follow Up

All involved vehicles have been entered into the DealerCONNECT Global Recall System (GRS) and Vehicle Information Plus (VIP) for dealer inquiry as needed.

GRS provides involved dealers with an <u>updated</u> VIN list of <u>their incomplete</u> vehicles. The Owner name, address and phone number are listed if known. Completed vehicles are removed from GRS within several days of repair claim submission.

To use this system, click on the "Service" tab and then click on "Global Recall System." Your dealer's VIN list for each recall displayed can be sorted by: those vehicles that were unsold at recall launch, those with a phone number, city, zip code, or VIN sequence.

Dealers <u>must</u> perform this repair on all unsold vehicles <u>before</u> retail delivery. Dealers should also use the VIN list to follow up with all owners to schedule appointments for this repair.

Recall VIN lists may contain confidential, restricted owner name and address information that was obtained from the Department of Motor Vehicles of various states. Use of this information is permitted for this recall only and is strictly prohibited from all other use.



OWNER'S MANUAL ADDENDUM

THIS ADDENDUM PROVIDES INFORMATION ABOUT THE ROLLOVER WARNING FOR SECTION 1 OF YOUR OWNER'S MANUAL

Rollover Warning

Utility vehicles have a significantly higher rollover rate than other types of vehicles. This vehicle has a higher ground clearance, higher center of gravity, and narrower track than many passenger cars. It is capable of performing better in a wide variety of off-road applications. Driven in an unsafe manner, all vehicles can be caused to go out of control. Because of the higher center of gravity and the narrower track, if this vehicle is out of control it may rollover when some other vehicles may not.

Rollover Warning Label

Do not attempt sharp turns or abrupt maneuvers or other unsafe driving actions that can cause loss of vehicle control. Failure to operate this vehicle safely may result in an accident, rollover of the vehicle, and severe or fatal injury. Drive carefully.

Failure to use driver and passenger seat belts provided is a major cause of severe or fatal injury. In fact, the U.S. government notes that the universal use of existing seat belts could cut the highway death toll by 10,000 or more each year, and could reduce disabling injuries by 2 million annually. In a rollover crash an unbelted person is significantly more likely to die than a person wearing a seat belt. Always buckle up.
