Dear ACDelco Customer:

This notice is sent to you in accordance with the requirements of the National Traffic and Motor Vehicle Safety Act.

ACDelco supplier, Affinia, has decided that a defect that relates to motor vehicle safety exists in certain brake hydraulic master cylinders. As a result, Affinia is conducting a safety recall. Our records indicate that you may have purchased the subject brake hydraulic master cylinders from ACDelco. A detailed list of these purchases is attached. We apologize for this inconvenience. However, we have taken this action for your safety and continued satisfaction with our ACDelco products.

**Why are the
brake master
cylinders being
recalled?**

When subjected to very cold temperatures, i.e., below 5 degrees Fahrenheit (-15 Celsius), an internal seal in the master cylinder may lose flexibility. This condition may cause brake fluid to leak, leading to a decrease in brake line pressure and an increase in stopping distance. The driver may feel a distending, or spongy brake pedal, and/or notice a warning brake lamp light on the vehicle instrument panel. This condition could lead to a vehicle crash.

**What should
you do?**

TO: General Motors Service Parts Operations and ACDelco Distributors and Installers

Re: Recall of Certain AC Delco Hydraulic Master Cylinders (Only Part Numbers/Date Codes Listed in Table 1)

Dear Valued Customer:

This notice is sent to you in accordance with the requirements of the National Traffic and Motor Vehicle Safety Act. Affinia Group Inc. has decided that a defect which relates to motor vehicle safety exists in certain brake hydraulic master cylinders manufactured by its subsidiary, Brake Parts Incorporated (BPI), and supplied to you. These products were intended for aftermarket installation on the vehicle applications listed in Table 1 below.

Identification of brake hydraulic master cylinders covered by recall

The subject brake hydraulic master cylinders were manufactured from July 27, 2005 through January 17, 2006, and were sold exclusively in the aftermarket. The part numbers and the intended vehicle applications of the affected products are listed in Table 1.

Important Note: Only products with date codes 342105210 through 342106017 on the packaging label are subject to this recall.

Description of Defect

When subjected to very cold temperatures, i.e., below 5 degrees Fahrenheit (-15 Celsius), an internal seal in the master cylinder could lose flexibility. This condition may cause brake fluid to leak, leading to a decrease in brake line pressure and an increase in stopping distance. The driver may feel a distending, or spongy brake pedal, and/or notice a warning brake lamp light on the vehicle instrument panel. This condition could lead to a vehicle crash.

What You Should Do

(a) **Recalled product in inventory:** Our records indicate that you may have purchased the subject brake hydraulic master cylinders from us.* You will receive reimbursement for the master cylinders returned including freight charges. Replacement brake hydraulic master cylinders are available for shipment to you. ***Under federal law, you may not sell the recalled brake hydraulic master cylinders.*** Please return them to us for reimbursement as soon as possible.

(b) **Recalled product in the hands of your customers and owners:** Please forward copies of this letter to reselling customers who have purchased from you. They will be provided free replacement brake hydraulic master cylinders on the same basis as above.

We also request that you transmit copies of the attached letter to owners through your distribution system. It advises owners of steps to be taken by them to obtain and have installed replacement brake hydraulic master cylinders free of charge. Alternatively, you may provide customer contact information to Affinia, and Affinia will coordinate notification to these customers.

We are requesting that installers remove the existing brake hydraulic master cylinders and install the replacement at no charge to your customer. Affinia will reimburse you for 2 hours of labor. Invoices for this work should include customer name, RG12006 tracking code, quantity, and part number(s) and sent to:

These products were marketed by **ACDelco** under the **ACDelco** brand name. Affinia is recalling the affected product.

WHAT PRODUCTS ARE INVOLVED?

This recall involves brake hydraulic master cylinders with the part numbers identified in the table below, and which were manufactured from July 27, 2005 through January 17, 2006. These products were sold exclusively in the aftermarket for use on the vehicles identified.

WHAT SHOULD YOU DO?

If you have purchased one of the subject brake hydraulic master cylinders through an installer, we urge you to contact your installing dealer as soon as possible to arrange an appointment to have the part replaced free of charge. The labor time to perform this service will be approximately 2 hours and labor will be free of charge to you. Replacement master cylinders are currently available at your installing dealer. The dealer will perform the remedy at no cost to you and will bill Affinia.
