

SAFETY RECALL-HEADLAMP/AMBER SIDE REFLEX REFLECTORS

Dear Poli-Auto, Inc. Headlamp owner:

This notice is sent to you in accordance with the requirements of the National Highway Traffic and Motor Vehicle Safety Act.

Poli-Auto, Inc. has decided that certain Poli-Auto, Inc. combination headlamp assemblies, p/nos. 11-728, 11-728D, 11-710, 11-419, 11-713, 11-703, 11-704, 11-708P, 11-735, 11-725, 11-726, 11-716(P&C), 11-721-1, 11-733, 11-729, 11-730, and 11-732 fail to conform to federal Motor vehicle safety standard no. 108, "Lamps, Reflective devices, and Associated Equipment." These combination headlamp assemblies may not contain required amber side reflex reflectors. Without the amber reflectors, the vehicle will be poorly illuminated, possibly resulting in a vehicle crash without warning. Owners of affected combination headlamp assemblies should drive safely, particularly at night, to reduce the chance that the malfunction will occur before the noncompliance is remedied.

Your item of replacement equipment, identified on the enclosed form, **is affected**. For this reason we ask that you arrange for repurchase to correct the condition without delay. Poli-Auto, Inc. will purchase your noncompliant combination headlamp back from you at its original purchase price.

To correct this condition, Poli-Auto, Inc. will purchase your noncompliant combination headlamp back from you at its original purchase price beginning on May 29, 2006. To obtain this free service:


Contact your dealer as soon as possible to schedule the repurchase.

Take the enclosed Owner Notification form with you at the time of your appointment and give it to your dealer. The form identifies the time of equipment that is to be repurchased.

If you have any problem obtaining the needed remedy, please contact the Poli-Auto, Inc. customer service at (305) 477-1356. A Poli-Auto, Inc. representative will arrange for prompt attention to the repurchase of your item of replacement equipment.

We regret any inconvenience which this action may cause you. However we are concerned about your safety.
