Subject: Customer Care Campaign X176- Safety Recall Fuel Tank Repair

To support customer satisfaction in conjunction with Recall R176, S-type Fuel Tank Repair, Jaguar Cars is extending a Certificate with a value up to \$125 to vehicle owners in the affected VIN range of N05049 to N52047. The certificate may be redeemed at any authorized Jaguar dealership in the United States and Canada. Certificates will be included with the owner notification letter.

The customer use of this Certificate will also generate service and parts revenue for your dealership; therefore, encourage its use by your customers within the affected VIN range.

Customer Care Initiative:

The Certificate can be applied towards the purchase of Jaguar accessory products, Jaguar Collection merchandise or vehicle maintenance and repairs.

- The Certificate can only be used for affected S-TYPE vehicles within the VIN range N05049 to N52047 that are part of the fuel tank recall
- The Certificate can be redeemed at time of the recall repair, but **not prior to** the performance of the recall action.
- The Certificate can be redeemed after performance of the recall repair at a future date as long as the customer uses the Certificate before the expiration date.
- The Certificate is valued at up to \$125 if redeemed for vehicle services or an accessory purchase
- The Certificate is valued at a maximum amount of \$50 if used to purchase from the Jaguar Collection only.
- The Certificate can be used to combine a service or accessory purchase and a Jaguar Collection merchandise purchase. The Certificate is valued at \$125 if applied in this fashion.
- The Certificate purchase must be made at an authorized Jaguar dealership.
- The Certificate will not have any residual value and the customer cannot redeem the Certificate for cash or credit in the event that the total purchase is less than \$125.
- The Certificate cannot be used after October 31, 2007

Jaguar dealers may claim reimbursement for the Certificate value redeemed by the customer, up to the maximum \$125 as defined above.

DDW Claiming Procedures

Follow the DDW procedure below to claim reimbursement for Certificate redemption value:

- Enter Repair Order data
- Use program code "X176" option code "X"
- The open date on the Repair Order must be on or before October 31, 2007 since the Certificate cannot be used by the customer after this date
- Under Miscellaneous Expense Code "Other"- enter the Certificate amount redeemed, not to exceed \$125
- Only one claim per eligible vehicle affected by the Recall will be accepted
- Warranty claims should be submitted in accordance with the current Jaguar Warranty Policy and Procedures Manual and its amendments unless stated otherwise in this bulletin
- All claims must be submitted and finalized for payment by November 30, 2007. Claims submitted after November 30, 2007 will not be approved

Required Documentation

To qualify for reimbursement of the Certificate, Jaguar dealers are required to submit the following documentation:

- Create a unique labor code with Certificate as the line description.
- For Reynolds DMS, create a Misc. code under the 3631 screen.
- For ADP DMS, create a code under the UOC screen.
- Enter the Certificate amount redeemed by the customer. Remember, the Certificate is valued at only \$50 if redeemed solely for a Jaguar Collection merchandize purchase
- Fax the <u>Customer Signed Invoice</u> copy of the repair order listing the affected VIN.
 Counter tickets will not be accepted as valid documentation. Fax to 866-500-9861.

A copy of the customer letter and Certificate is enclosed.

Record Keeping

It is recommended that you keep a file copy of the customer signed invoiced repair order with the Certificate attached.
